

Time Map IT-foundation - co-chairman at DCAG - Reality-TV Get-Response Management Function

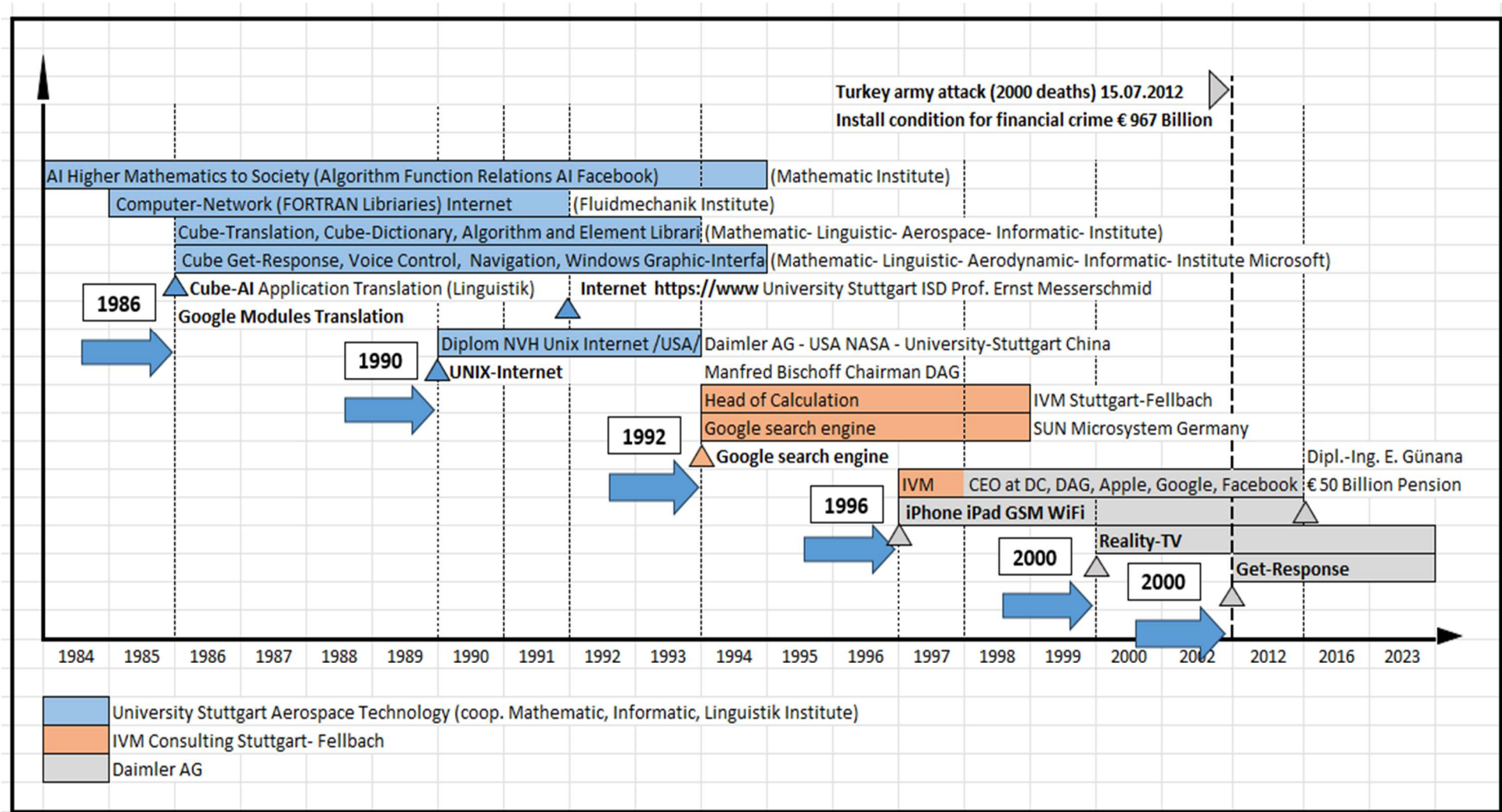


Chart 1: Timeline IT-Foundations, co-chairman job

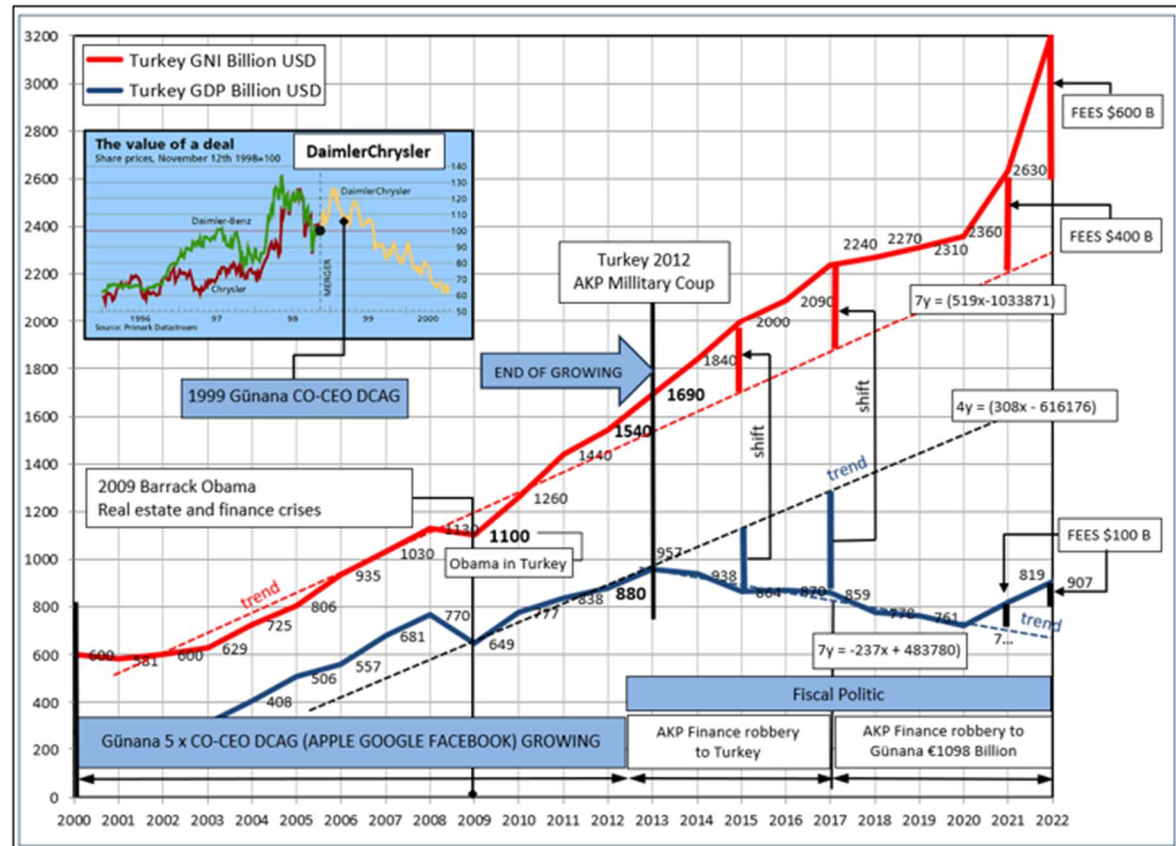


Chart 2 Turkey GNI -GDP 2000 - 2022

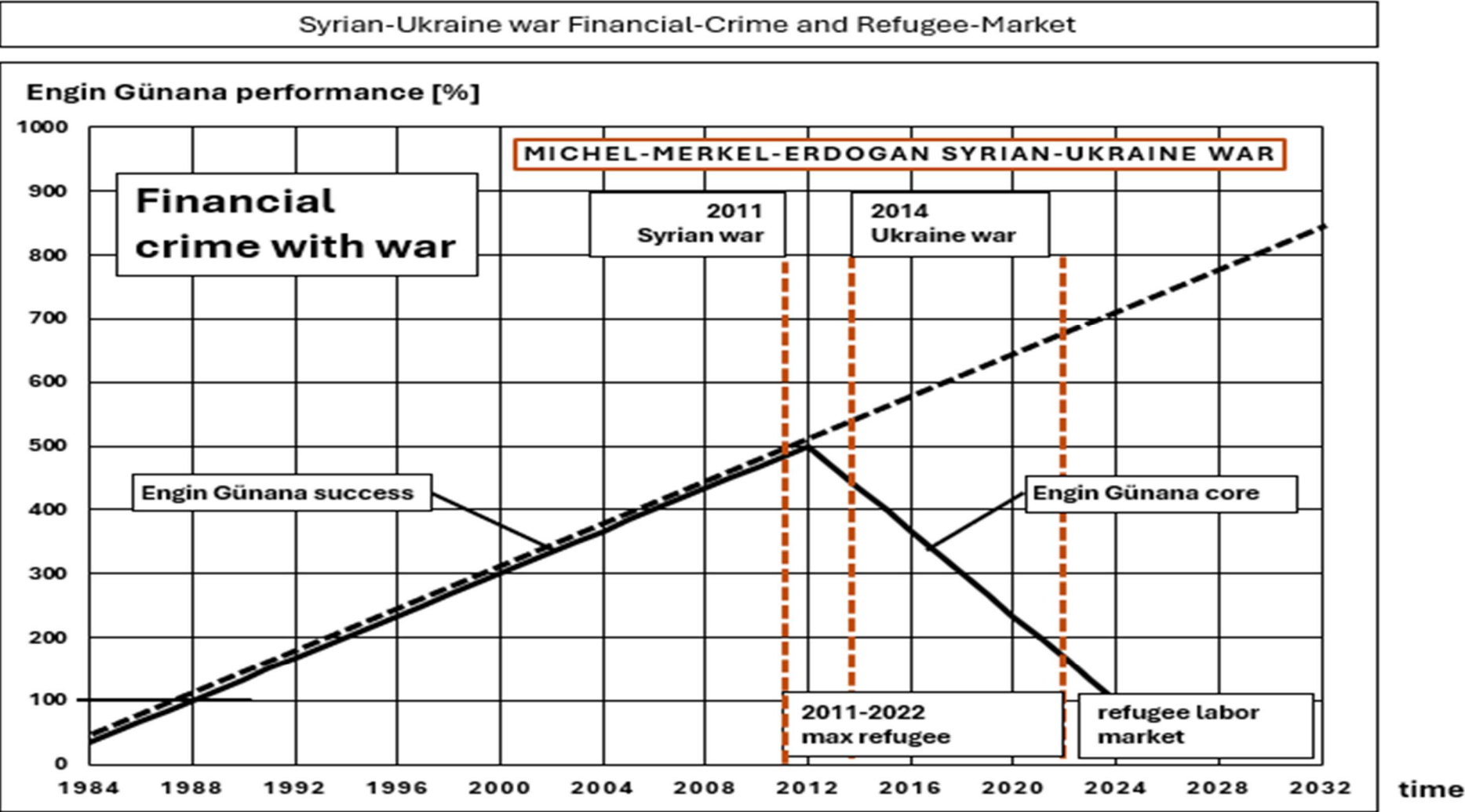


Chart 3: Syrian and Ukraine war and finance crime financial robbery Engin Günana



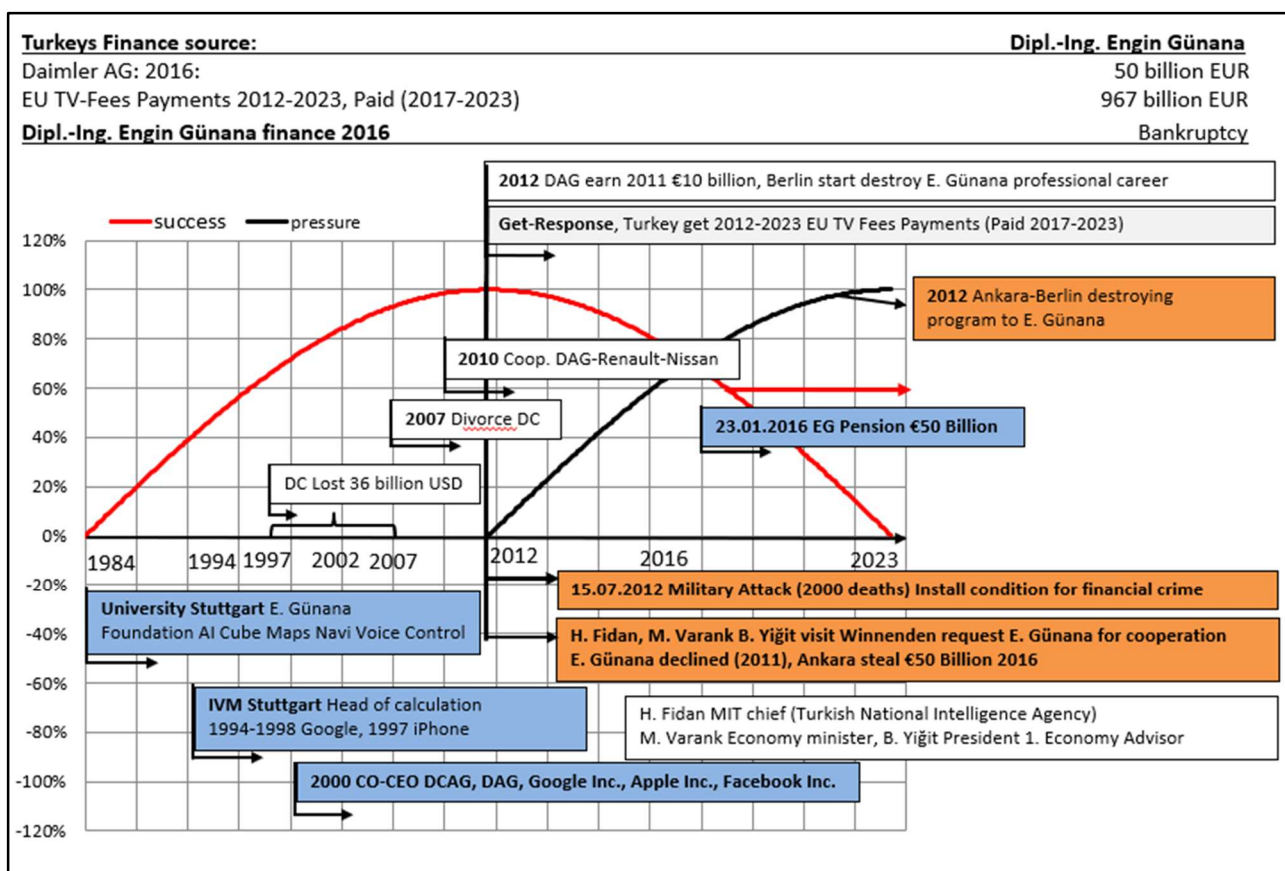


Chart 4: Timeline IT-Foundations, co-chairman job, Turkey's extortion program

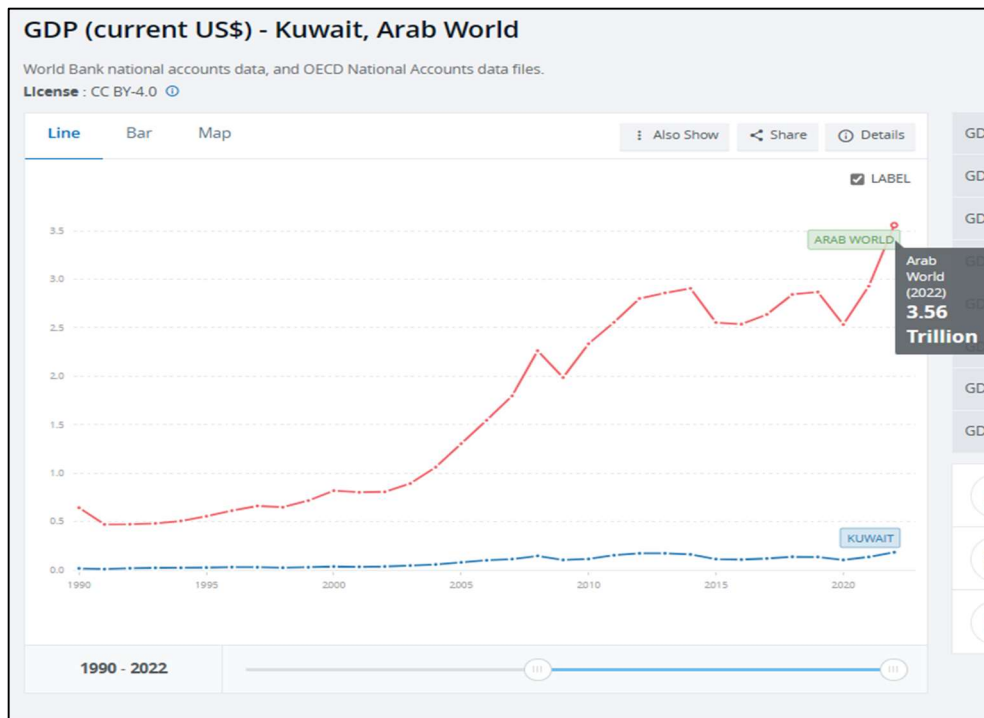


Ottoman Empire 1583

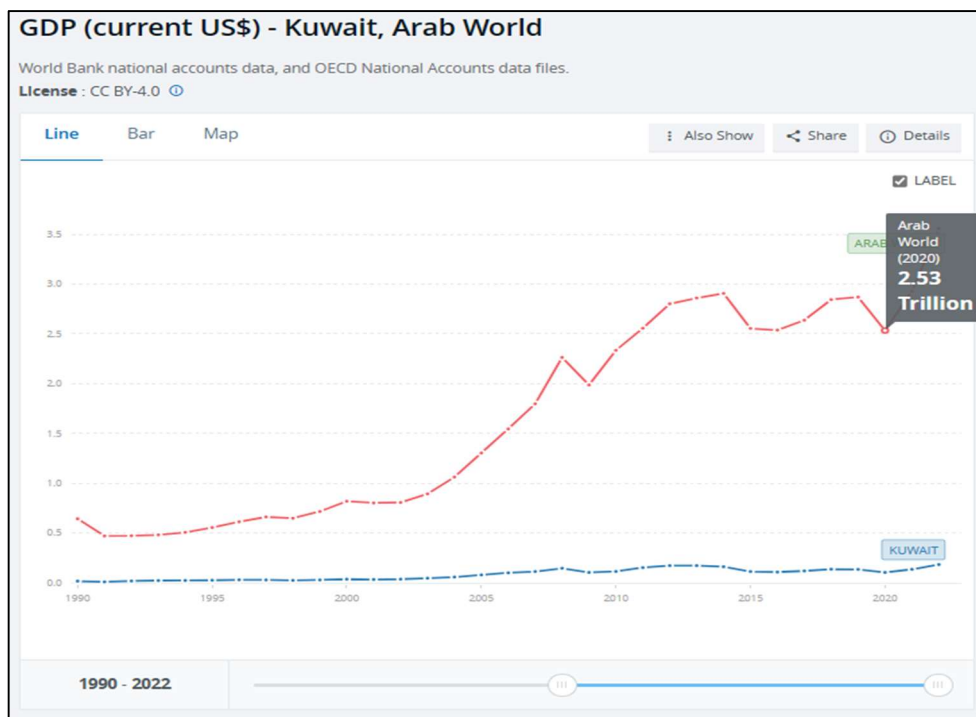

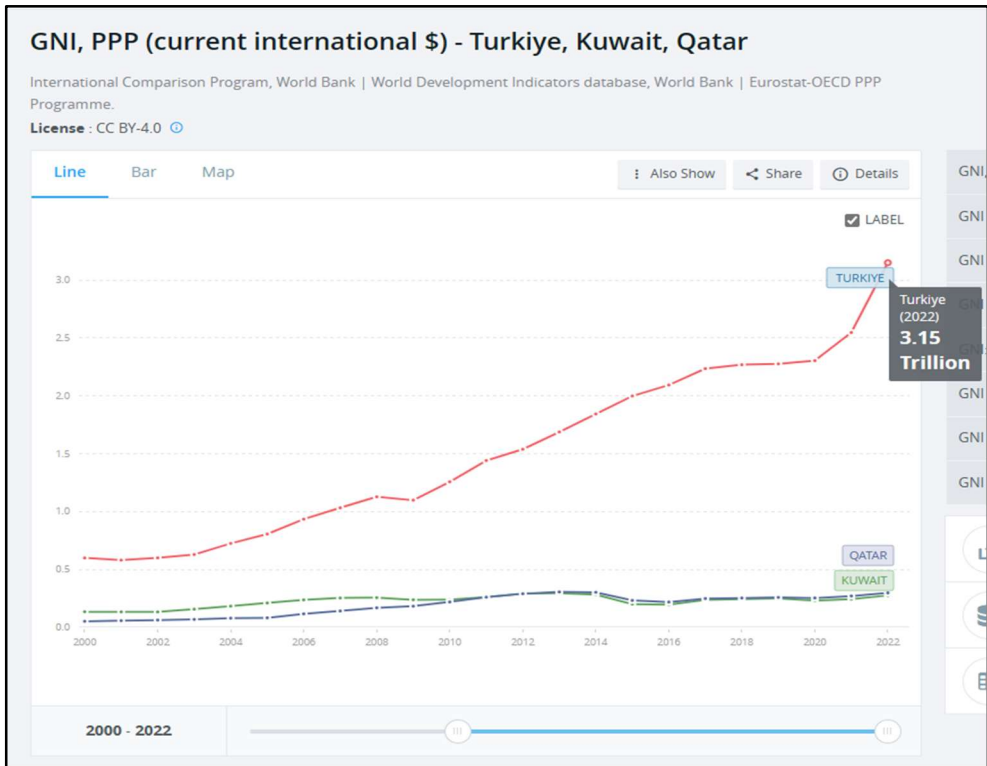


GDP [\$] Kuwait 2022, 3560 billion USD

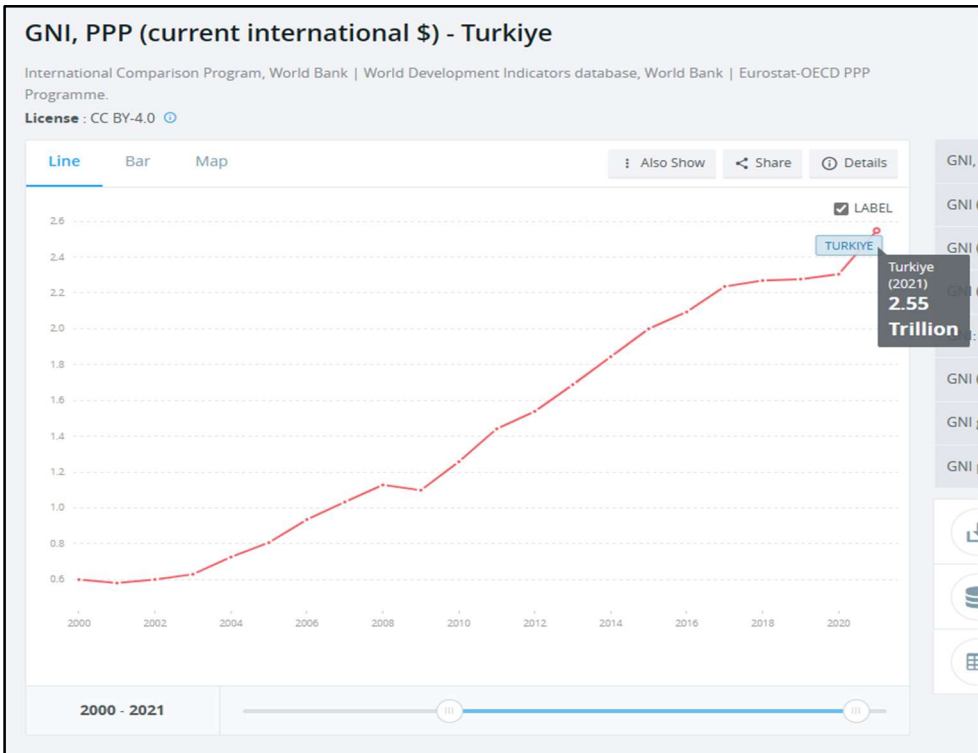


GDP [\$] Arab World 2021, 2530 billion USD

GNI Difference (2022 - 2021) 3150 billion USD - 2550 billion USD: 600 billion USD

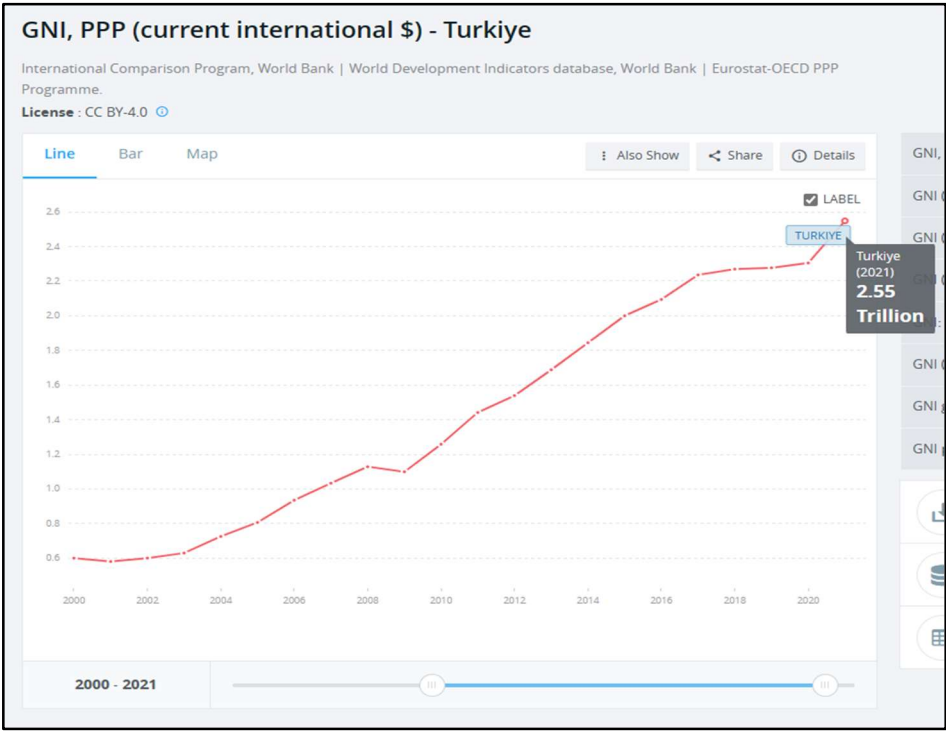


2022 Turkey GNI 3150 billion USD

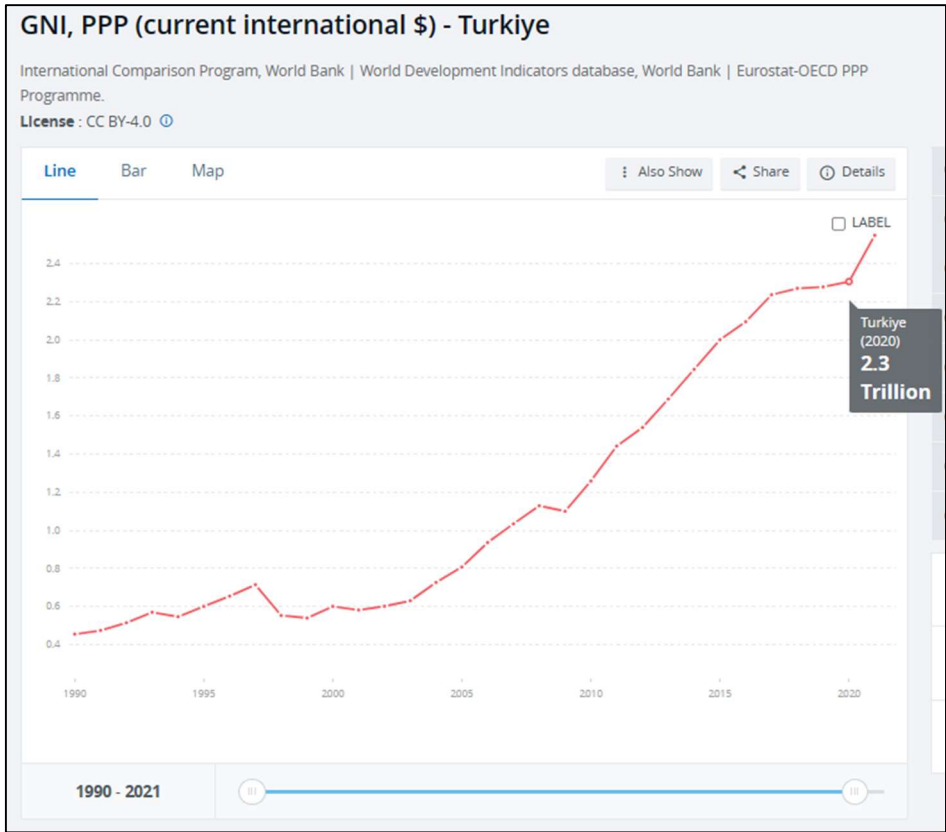


2021 Turkey GNI 2550 billion USD

GNI Difference (2021 - 2020) 2550 billion USD - 2300 billion USD: 250 billion USD

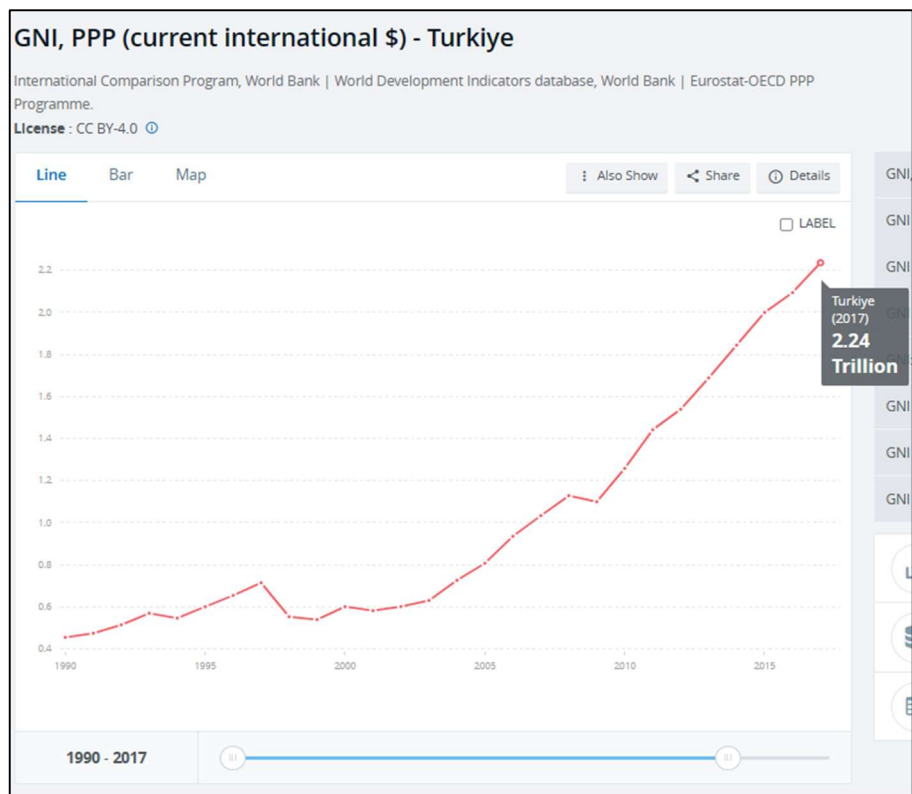

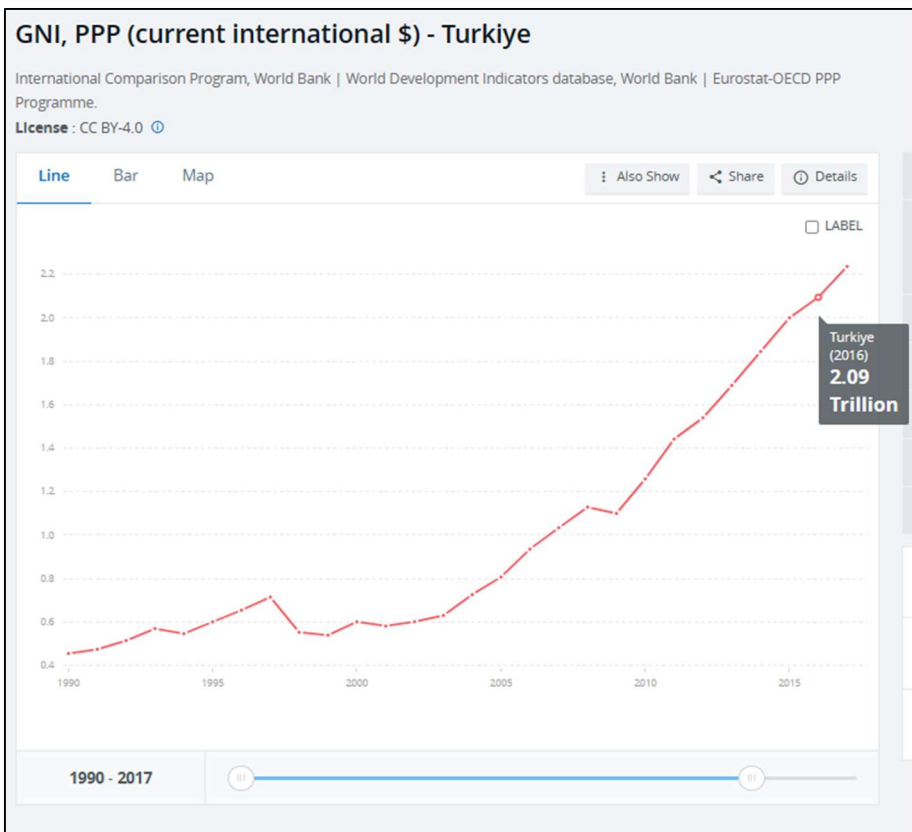


2020 Turkey GNI 2300 billion USD

GNI Difference (2017 - 2016) 2240 billion USD - 2090 billion USD: 150 billion USD

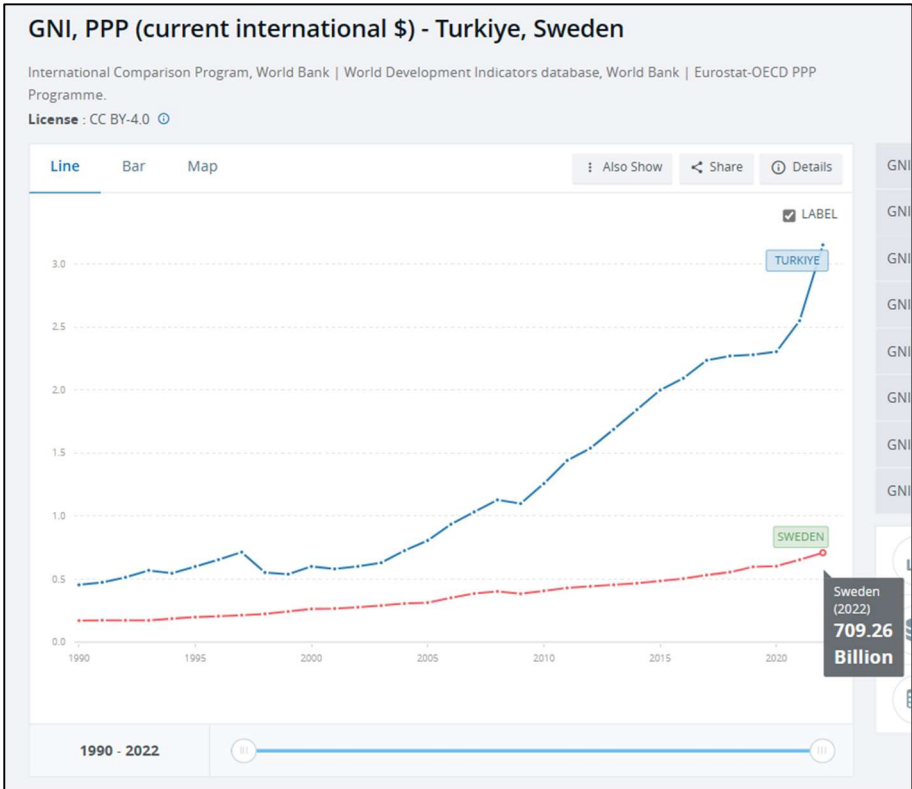

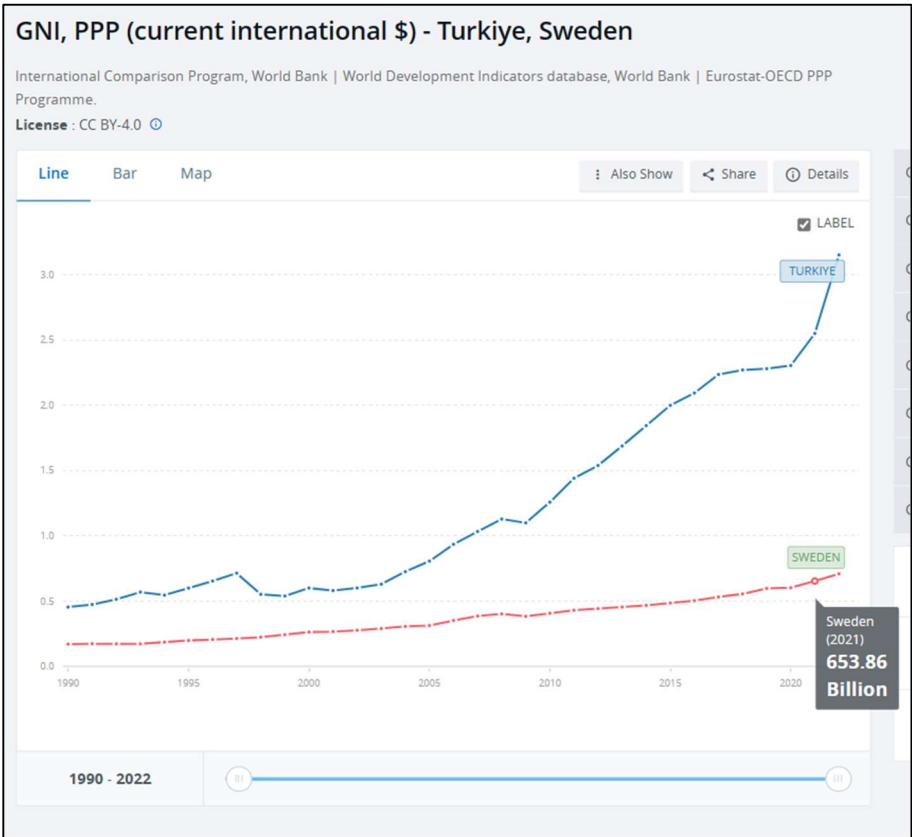


2016 Turkey GNI 2090 billion USD

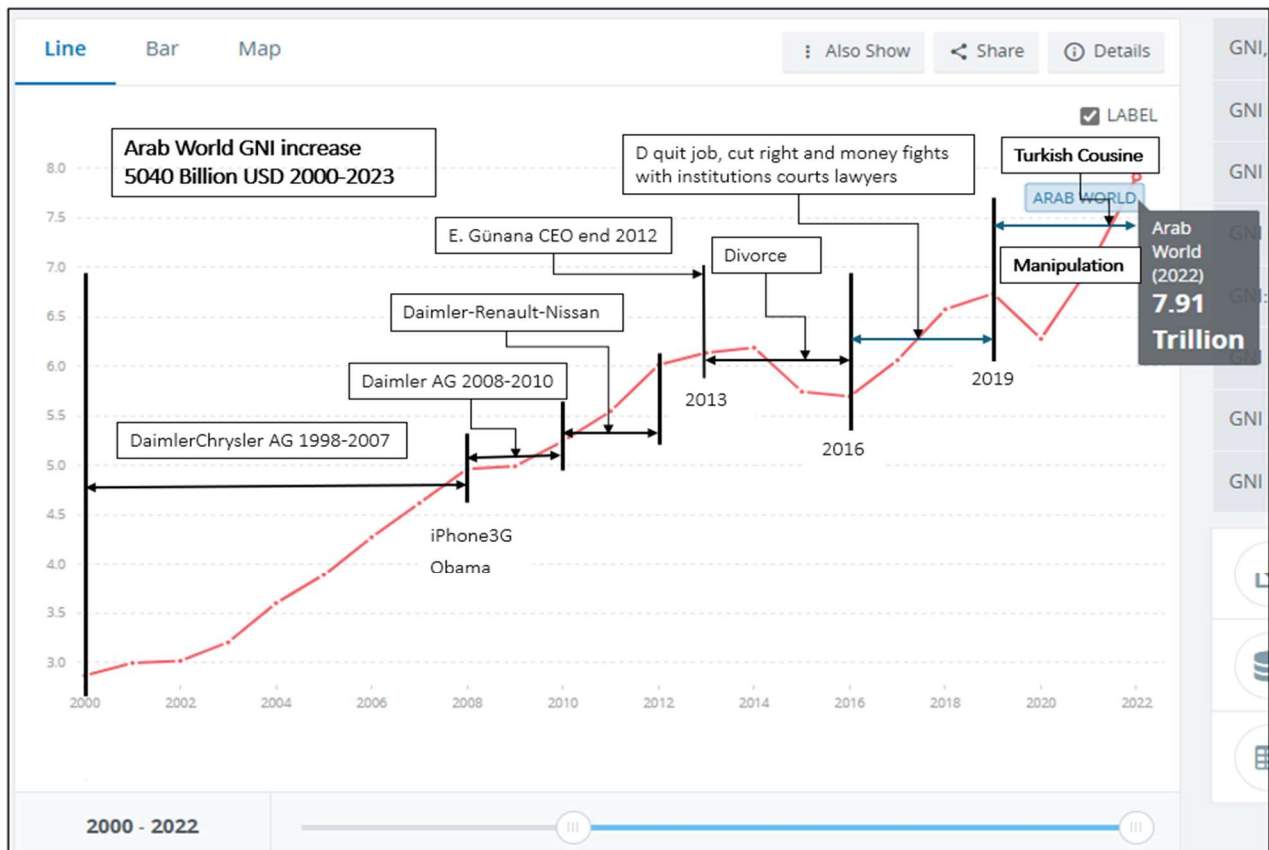

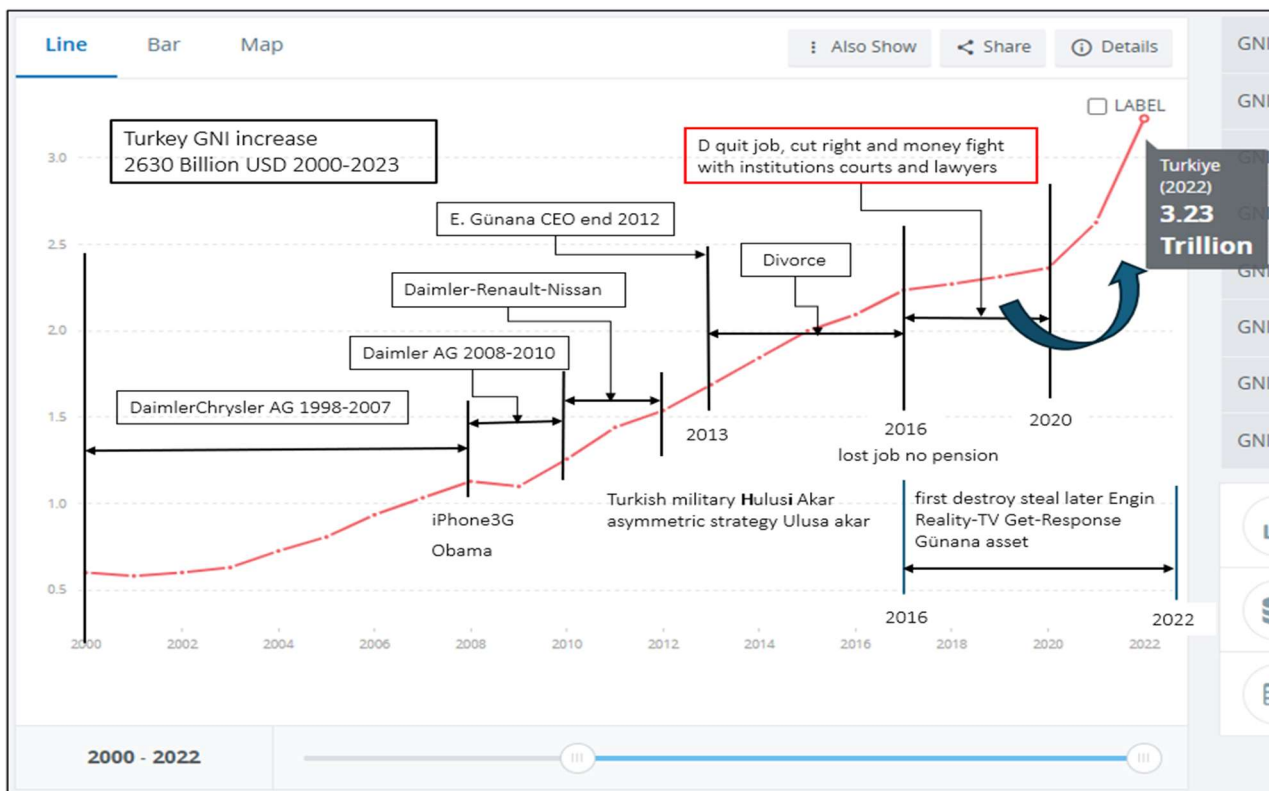

GNI Arab World (Ottoman Empire) and Turkey 2000-2022



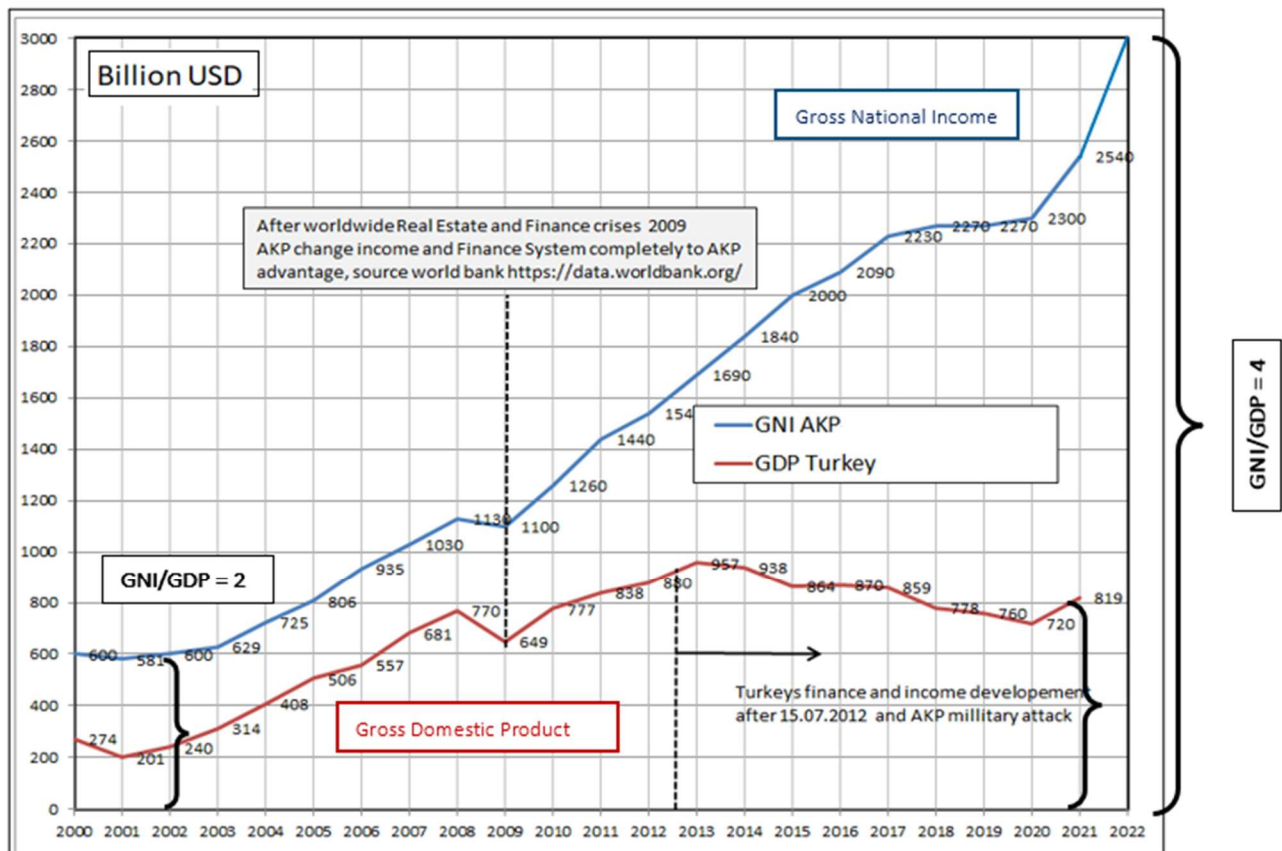
GNI Arab World 2000-2022 and Dipl.-Ing. Engin Günana Hotspots
