Get-Response Management function was installed to decouple Engin Günana physical from Daimler AG Management actual Mercedes-Benz Car Group Management (to escape regression) after IT foundations: Artificial Intelligence, Cube, Internet, Windows graphic Interface, Google, iPhone, GSM, Wi-Fi and CO-CEO function at companies DaimlerChrysler AG, Apple Inc., Alphabet Inc. (Google Inc.), Meta Technologies Inc. (Facebook Inc.)

12. Agreements over Get-Response Management Function F(t)

12.1 Get-Response management function is a spy function for interactive dialog with elementary screening and spying function of intellectual property to reach though contents with expert knowledge, management and business competence, but also useable for misusing with liar impacts. Agreement and contract with DaimlerChrysler AG Apple Inc., Google Inc., and Facebook Inc was done with physical meeting of partners Larry Page, Sergey Brin, Mark Zuckerberg, and with later with Daimler AG manager meetings with participation of E4 Helmut Michel, E3 Hans Jürgen Frey, E2 Peter Lückert, E1 Leopold Mikulic, Dr. Dieter Zetsche and Prof. Dr. Schrempp and Reality-TV function. Agreement and contract with European Union were made with Reality-TV function and EU politician Charles Michel visit Daimler AG.

12.2 Randomly encounter meeting after 2011 with Turkish and German politician at Daimler AG are pure randomly and not a part and scope of European Union Reality TV and Get-Response services and fees payments agreement and contract.

12.3 Randomly encounters after Reality-TV and Get-Response Management Function agreement and contract with European Union among other things former economy minister Mustafa Varank, economy and finance advisor Bülent Yiğit and secret service chief Hakan Fidan, private and without invitation are industry crime and not scope of European Union contract concerning Reality-TV and Get-Response Management Function.

Introduction

Engin Günana live divorced from Melike (Günana) since 01.10.2013 and is official divorced with court decision from family-court Böblingen/Germany from 10.10.2017.

Turkish government was obligated at 11/2017 from Consulate Stuttgart to fulfil divorce process in Turkey but in contrary to Böblingen court decision from 10.10.2017. didn't divorce Engin Günana

The reason is Turkish governments financial crime, capital fraud and corruption under misusing Melike Çorba fake marriage situation and coupling with marriage laws to Dipl.-Ing. Engin Günana since 10.10.2017.

Turkish government regulated to Dipl.-Ing. Engin Günana financial regular financial crime and capital fraud over Melike Çorba furthermore coupled fake marriage situation since 10.10.2017. A written request to Turkish local government at 20.01.2023 and 23.01.2023 to quit from Turkish citizenship is not in process. Two times personal visitation after 3 and 6 months at local government in Kocaeli/Turkey were ignored.

Turkish national government misused Turkish national government institution justice-system, finance-system, healthcare-system with dictatorship rules (since 15.07.2012) and didn't realize the divorce process from Turkish nationality with the target to steal furthermore Dipl.-Ing. Engin Günana merit, income, payment and asset.

With a military and extortion coup Turkish national government steal Dipl.-Ing. Engin Günana 600 billion USD at 23.09.2023 part payments from European Union (EU) for Reality-TV and Get-Response services, see lawsuit about 2500 billion EUR against EU and Turkish government.

Turkish government, President Erdoğan and AK-Party steal 01/2016 Dipl.-Ing. Engin Günana 50 Billion EUR payment from Daimler AG at 01/2016, which was send over Mercedes-Benz Bank to Turkey with BND and MIT support and foundation Turkish Wealth Fund TWF with a capitalization 50 Billion EUR, declaration President Erdoğan as Chairman, foundation a pension insurance and send 11 million AK-Part members to pension and pay Ali Tekeşin, Melike Çorba, Fevzi Yıldırım, Göksal Günana, President Erdoğan friends colleagues officers, secret police, MIT employees fat salaries, during Turkish government bankruptcy Dipl.-Ing. Turkish government steal fake marriage condition Dipl.-Ing. Healthcare-System generate regular false medical reports, court produce false court decisions with pro government AKP judges who cooperate with federal court of Justice Ankara and Karlsruhe. Target is always stealing monthly EU-Fess Payments about 3.92 billion EUR.

Meanwhile German and Turkish government destroy Dipl.-Ing. Engin Günana professional career (regular after 2012). Even though he was founder of Artificial Intelligence, Internet, Google, iPhone, iPad, Facebook, YouTube and in CEO function at Daimler AG and DaimlerChrysler during 2002-2012, with the best earning of Daimler AG history. Dipl.-Ing. Between a few weeks, hundreds of new shops and buildings founded and pursue. Many companies and start-up companies founded and initialled for public offering over Turkish Stock-Exchange Istanbul from Yapı Kredi Bankası Çayırova/Kocaeli Turkey.

Çayırova have 150.000 citizens, most of them are now in pension, from Turkish Wealth Fund or SGK. Çayırova/Kocaeli is a city of workers, who earn monthly ca. 200-300 EUR, but most of them own cars about 100.000 EUR, everyday new buildings and stores increase. If I went to Turkish Yapı Kredi Bankası in Çayırova, a stage of constructed dialogue and action wait to me to steal me money without my expression authority, over parallel discussion and channels. During I get a little amount from my bank account, employees pay parallel to other recipients with temporary bank accounts and money transfer.














Chart 36 GNI – GDP Turkey drift after military attack 15.07.2012 (Capital transfer to outland)




as film and program directors who steal regularly Engin Günana merit, a lawsuit against European Union, Germany and Turkey is absolute necessary.
