Time Map of IT - Technology and Business

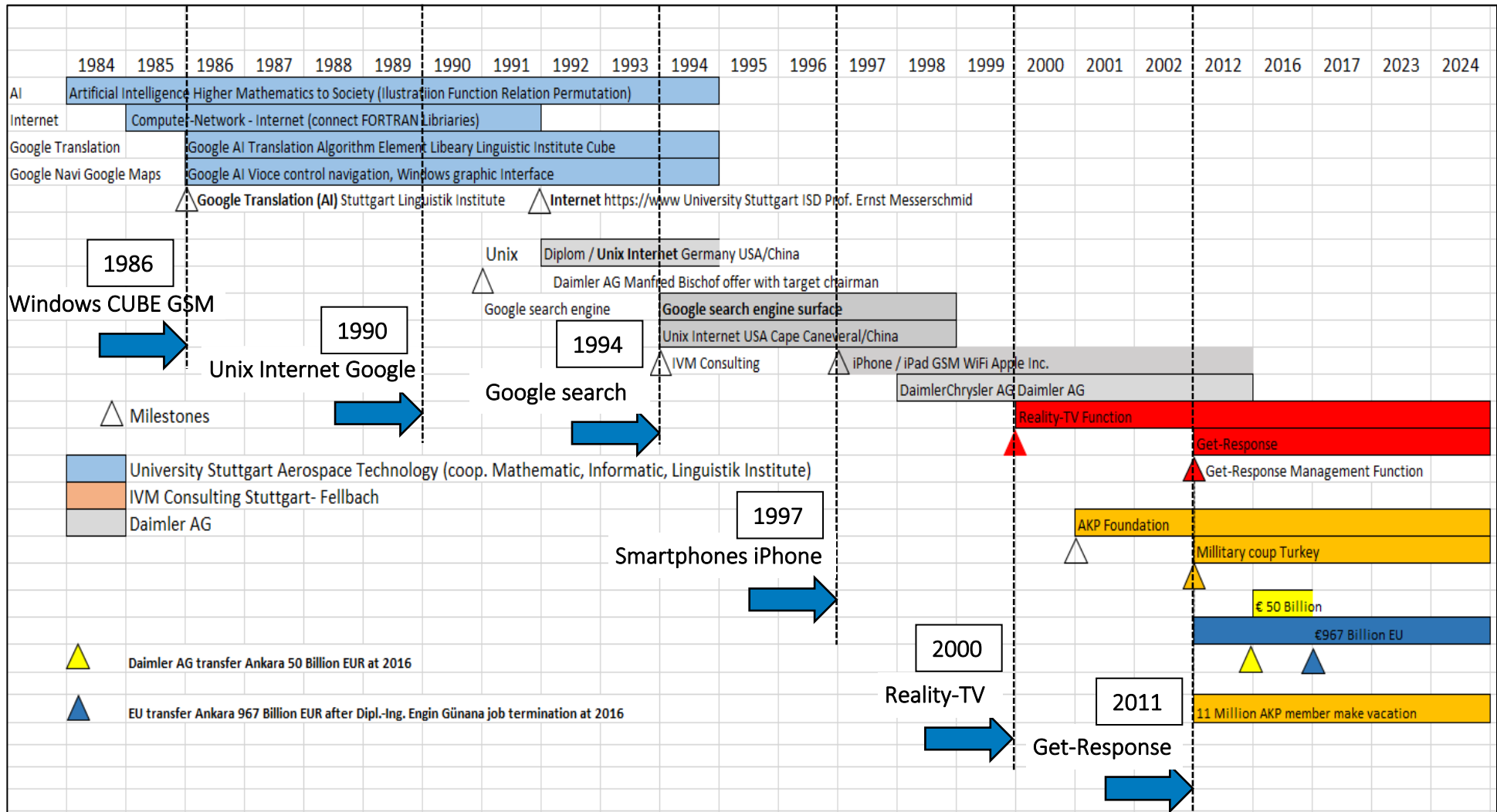


Chart 1: Timeline IT-Foundations, co-chairman job

IT-foundations, project leadership in foundations: Artificial Intelligence (AI), Cube, Internet, AI-translation, AI-voice commands, AI-voice control, AI-Maps, GSM 1G 2G mobile Internet, worldwide successful with beginning in USA and China, rollout 1990-1992 in USA and China. German Industry reserved after German Union in 1990 and under constrained financial condition regarding accordingly IT development investigation. Worldwide most important IT-Foundations at University Stuttgart 1984-1994

Experience at IT-Foundation and development manager in IT-Projects: Artificial Intelligence, Internet, cube, matrix and string theory with speech discretization and coupling with orthogonal condensation methods, fast Forward Fourier transformation for voice recognition with Intercultural competence and partners integration in Google (module) between 1984-1992. Connect Internet with international project and partners to USA and China and finally iPhone project 1997 with Apple Inc. was the initial reflection of Daimler AG Chrysler merger 1998.

Initial reflection for international cooperation from Daimler AG and USA started already in 1994 at IVM-Consulting Stuttgart-Fellbach, with existing contact to US partner Sergey Brin and Larry Page and Google Inc. Second contact with USA started in 1996 with a few partners among other things with Apple Inc. regarding multi device for project leader and manager.

iPhone project was a parallel external project with Apple Inc. and Steve Jobs during 1997-2012 in agreement with Daimler AG as second job without ant interface to Daimler AG development. Steve Jobs was acquired from Next company to Apple Inc. and started as chief project engineer at Apple Inc. for iPhone project with Engin Günana (second job without Daimler AG participation) the beginning of first contacts with US-passenger car companies end with a merger acquisition of Chrysler Inc. in 1998.

Chairman Prof. Jürgen Schremp and Board of member Daimler AG ordered Engin Günana to co-chairman position according supervisor chairman Manfred Bischof Daimler AG proposal during graduation at department Dr. Kern 1992 after DaimlerChrysler AG merger 1998 get a cold shower at New York stock exchange lost more than 60%. Constrained time condition was the result of different contract and agreement regulation than classic written variant.

Helmut Michel E4 and Hans Frey E3 was ordered from Board pf management and authorized for matching. Agreement first and second earning to protect substantial profit. Between 2-3 days encounter meetings with director Leopold Mikulic E1 and CEO Dr. Dieter Zetsche and chairman Prof. Dr. Schremp for accepting. Prof. Dr. Schrempp/Daimler AG and chairman Robert Eaton/Chrysler Inc. pushed Dipl.-Ing. Engin Günana to co-chairman job, this was the next logical step from Daimler AG after supervisor chairman Dr. Manfred Bischof proposal. Therefore, chairman Robert Eaton contract end in end of 1999.

Co-chairman Engin Günana introduce new program for manager qualifying, manager agreement, manager salary, manager conditions, and manager meetings proved and evaluated with meetings from Prof. Dr. Schrempp/Daimler AG and chairman Robert Eaton/Chrysler Inc Dr. D. Zetsche and directors at Daimler AG. Easy examples were handshake and head nodding. New proposal and guideline of Engin Günana management conditions was accepted and realized in 1999 as new capture of risk management after DaimlerChrysler AG shares felt at New York stock exchange extremely

Agreement and contract with partner DaimlerChrysler AG, Prof. Jürgen Schrempp, Robert James Eaton, evident Dr. Dieter Zetsche, Dr. Leopold Mikulic (E1), Dr. Joachim Schommers (E2), Peter Lückert (E2), Dr. Hans Frey (E3), Hans Michel (E4) with the target to protect DaimlerChrysler AG from insolvency and push to substantial profit with 10% profit after DaimlerChrysler AG shares lost in 1999 and 2000 extremely. First two earnings of Daimler AG as substantial protection of potential growing own Dipl.-Ing. Engin Günana. After Daimler AG divorce from Chrysler in 2007 and Barrack Obamas Real Estate and Financial crises in 2009.

## Summary 5 Reasons for CEO Mission at DaimlerChrysler AG 1998-2007 and Furthermore

DaimlerChrysler AG (DCAG) stocks felt extremely during Chrysler Inc. expenditure increase and vehicle market lost extremely in USA. Engin Günana decided with Dr. Zetsche divorce Daimler-AG (DAG) and Chrysler Inc. Günana business program and profit at 1. year was the benefit for Günana engagement no time for education and development to Board of Management regarding Manfred Bischof proposal in 1992 to E. Günana, time to act. 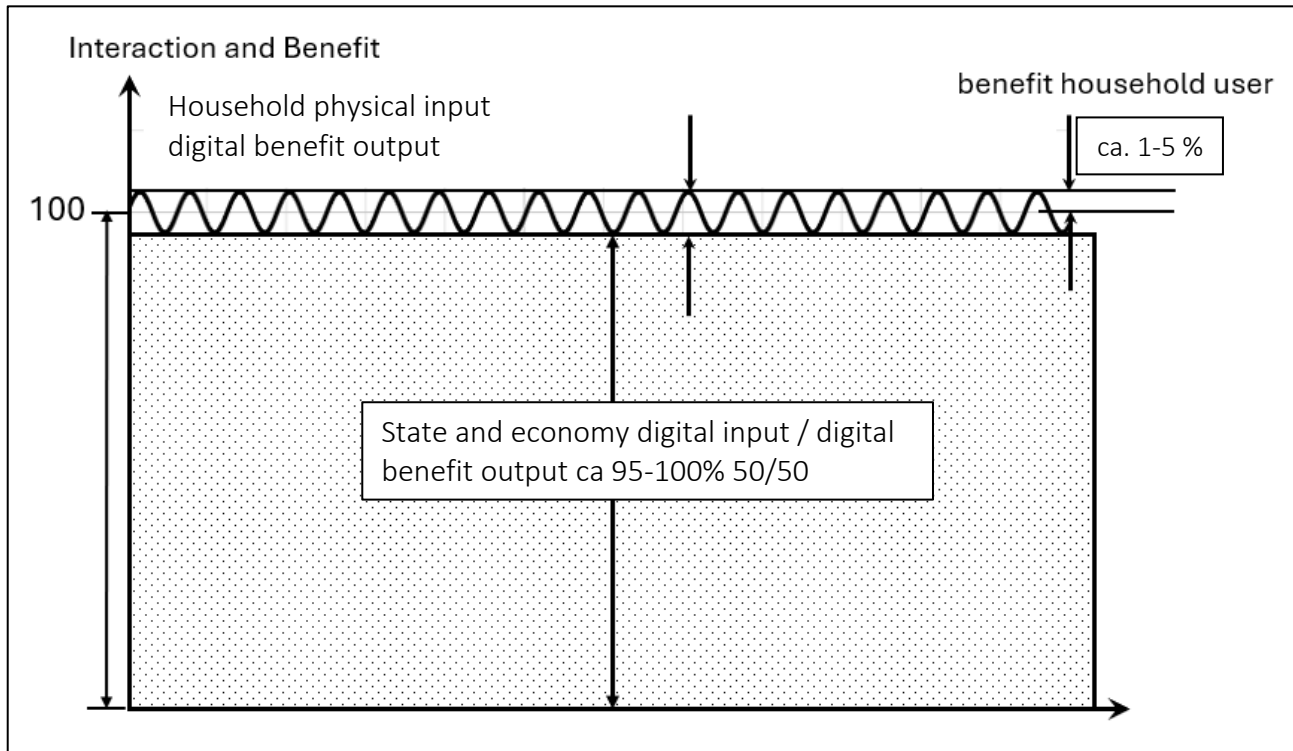

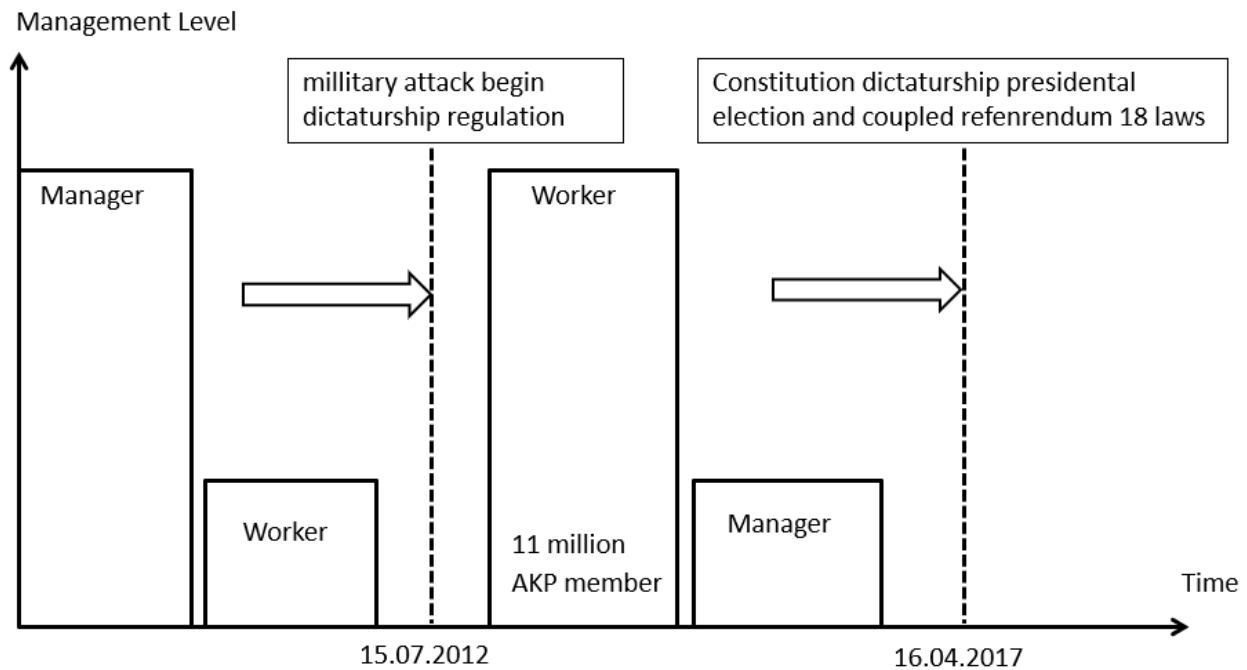

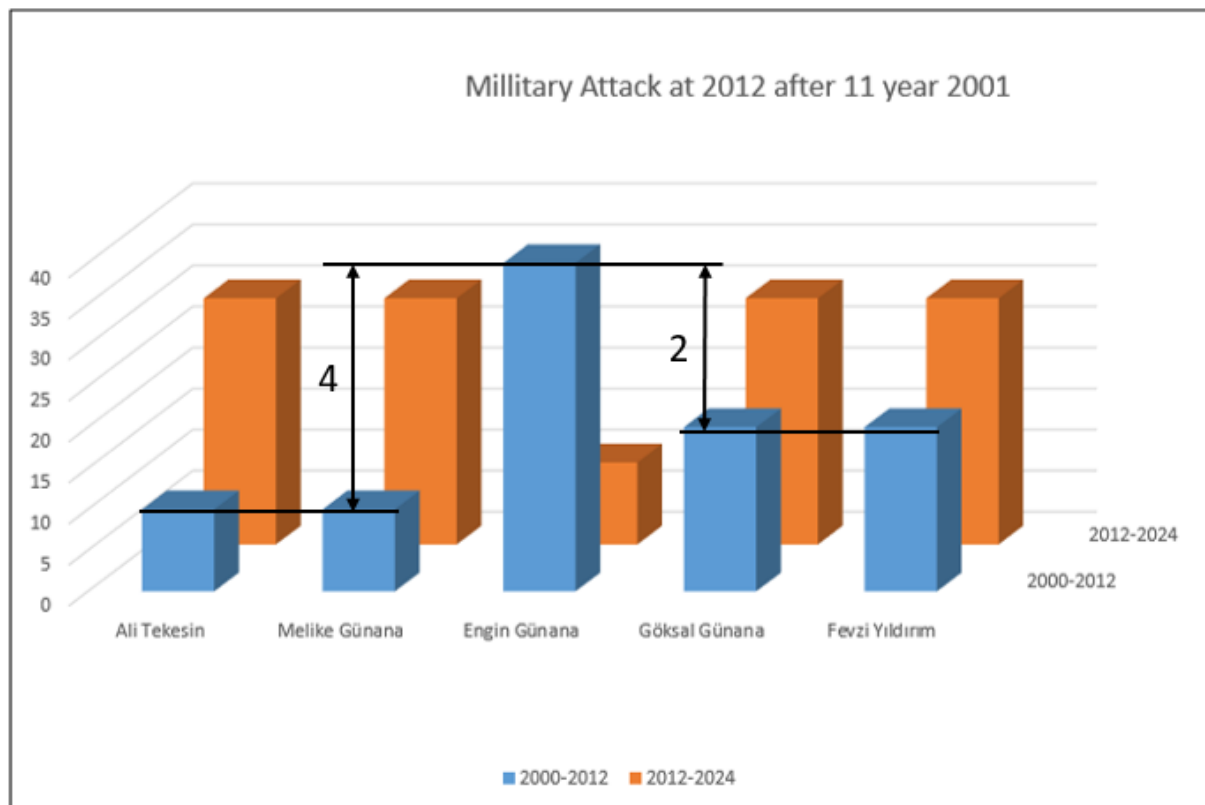

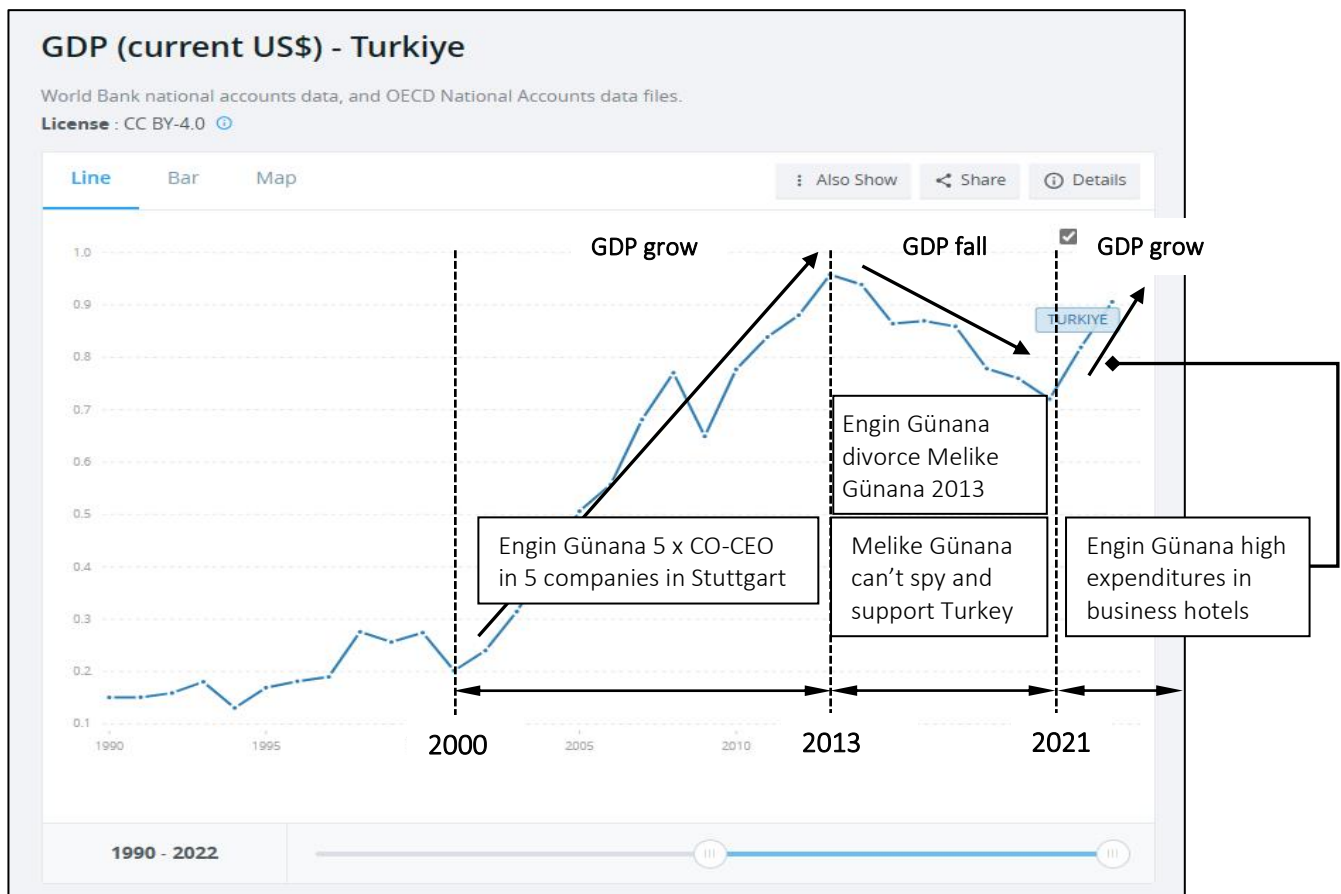

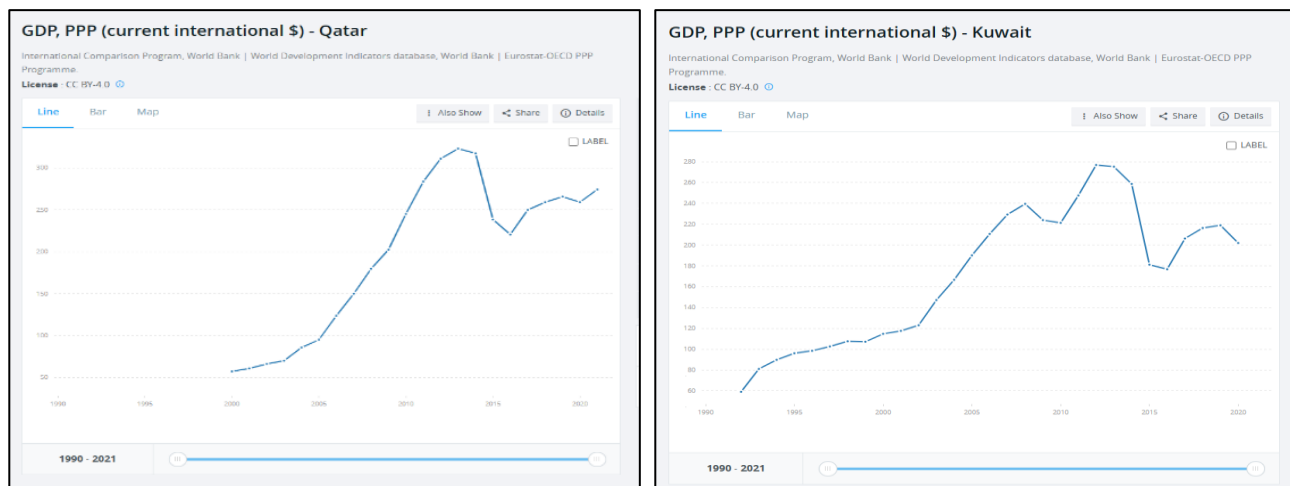

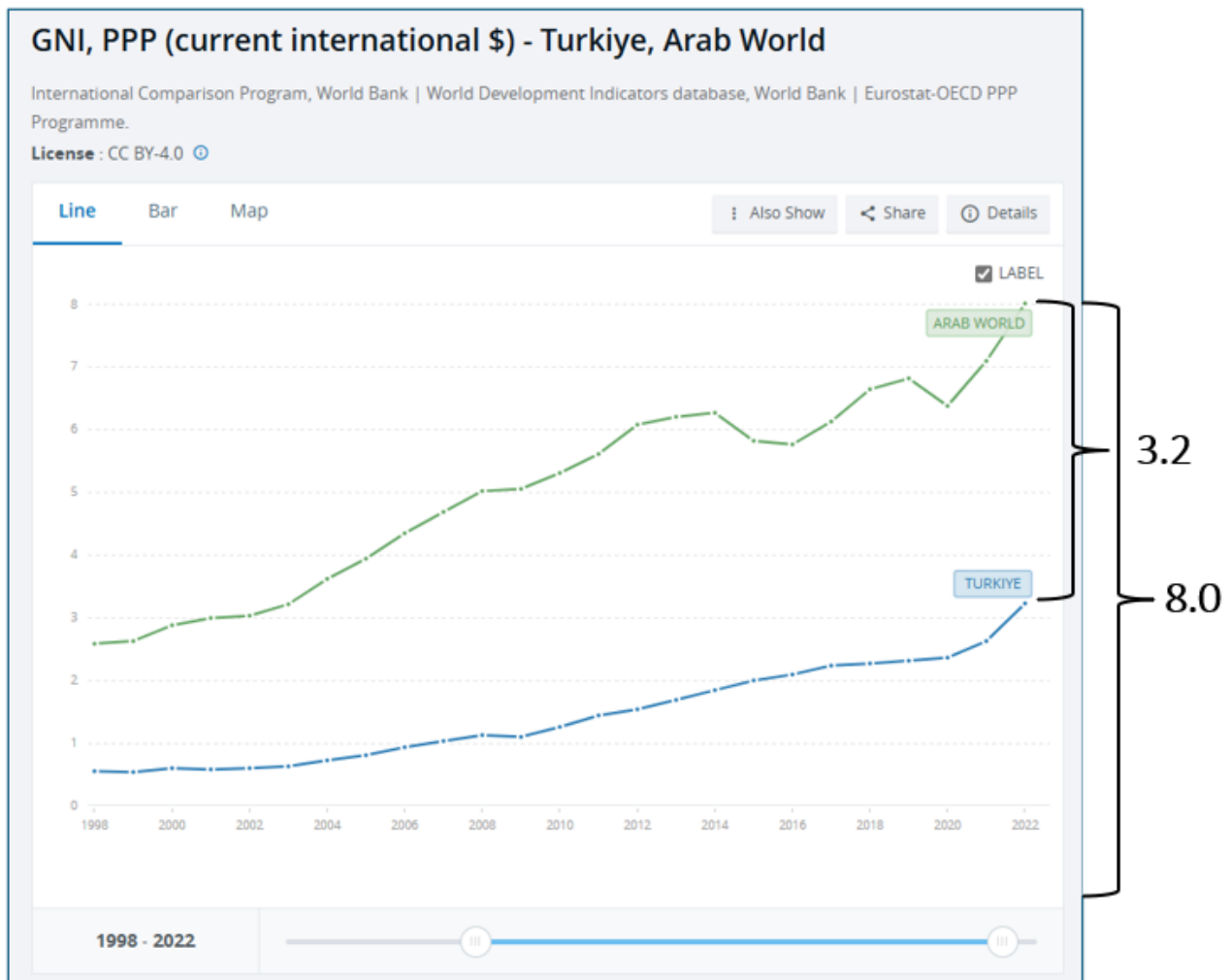

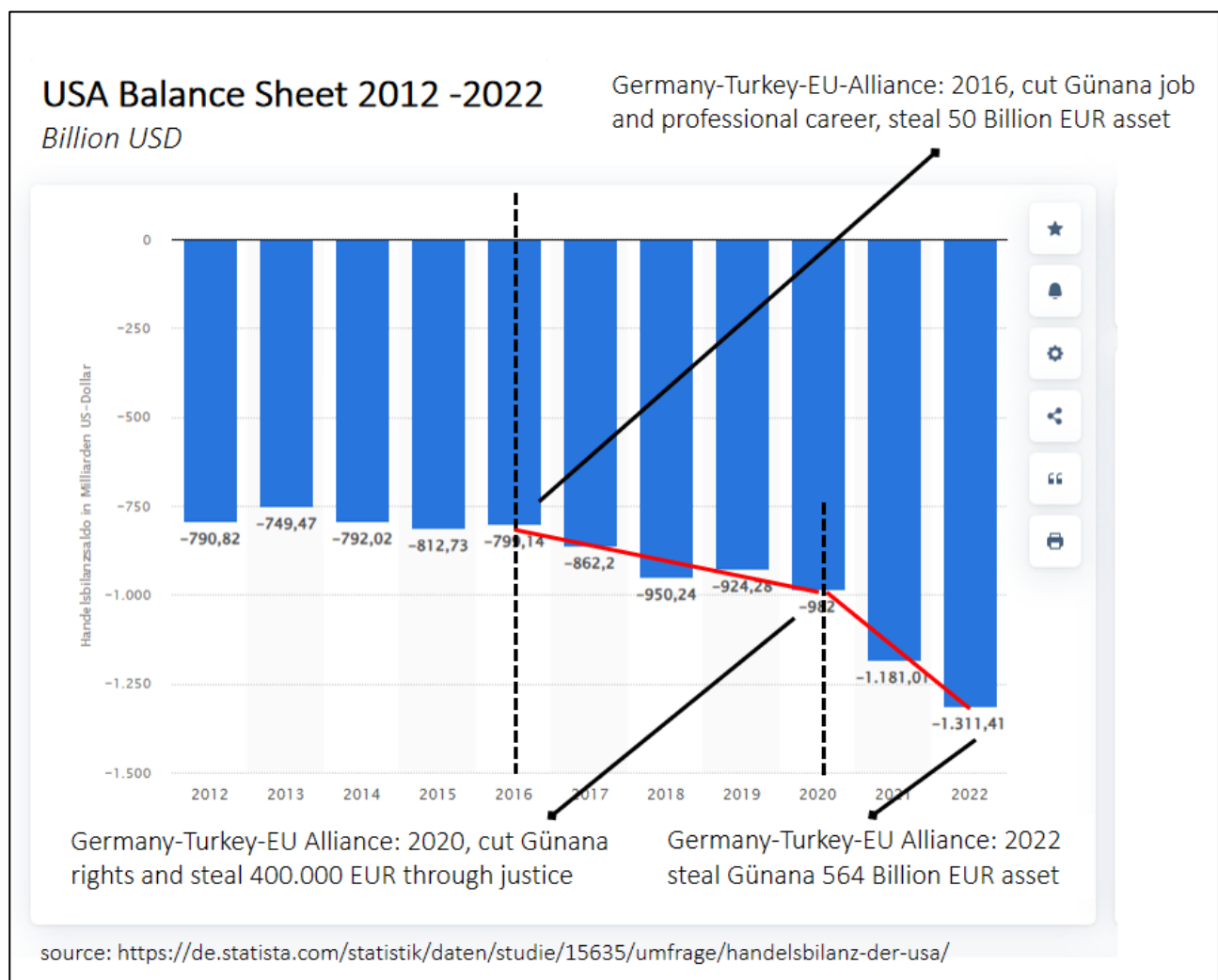

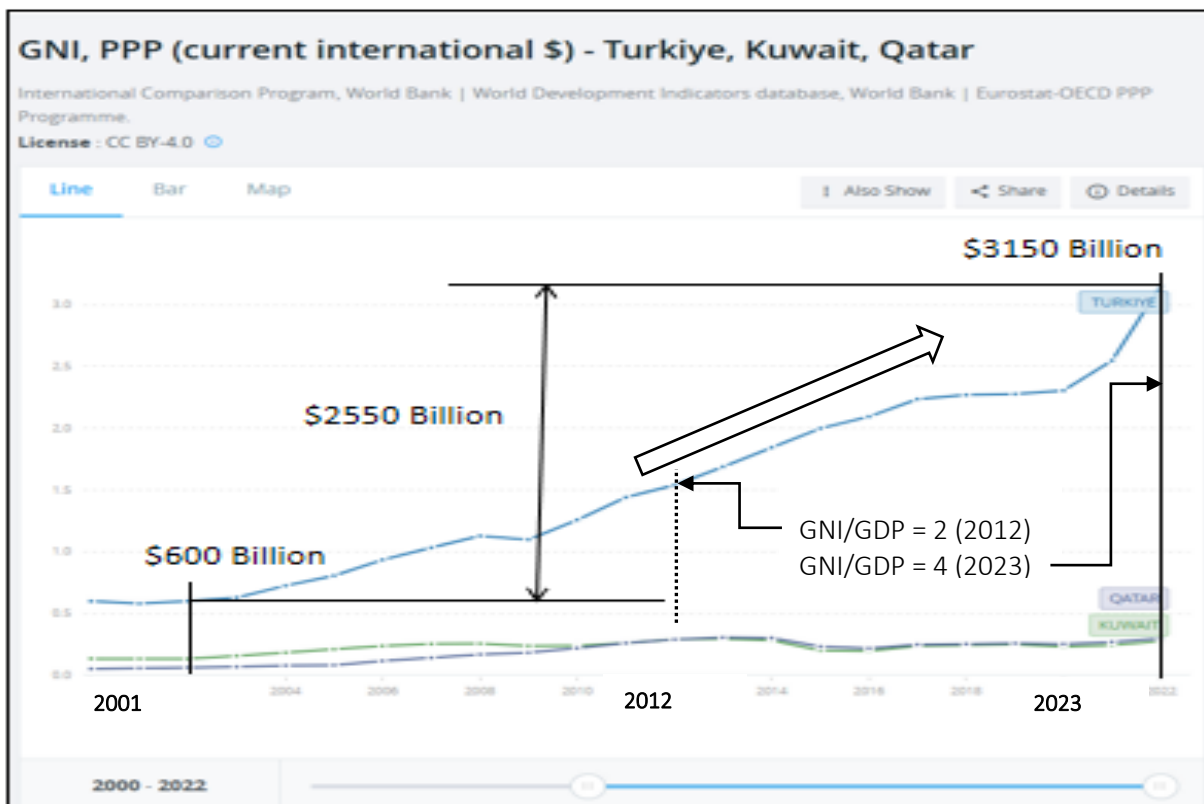
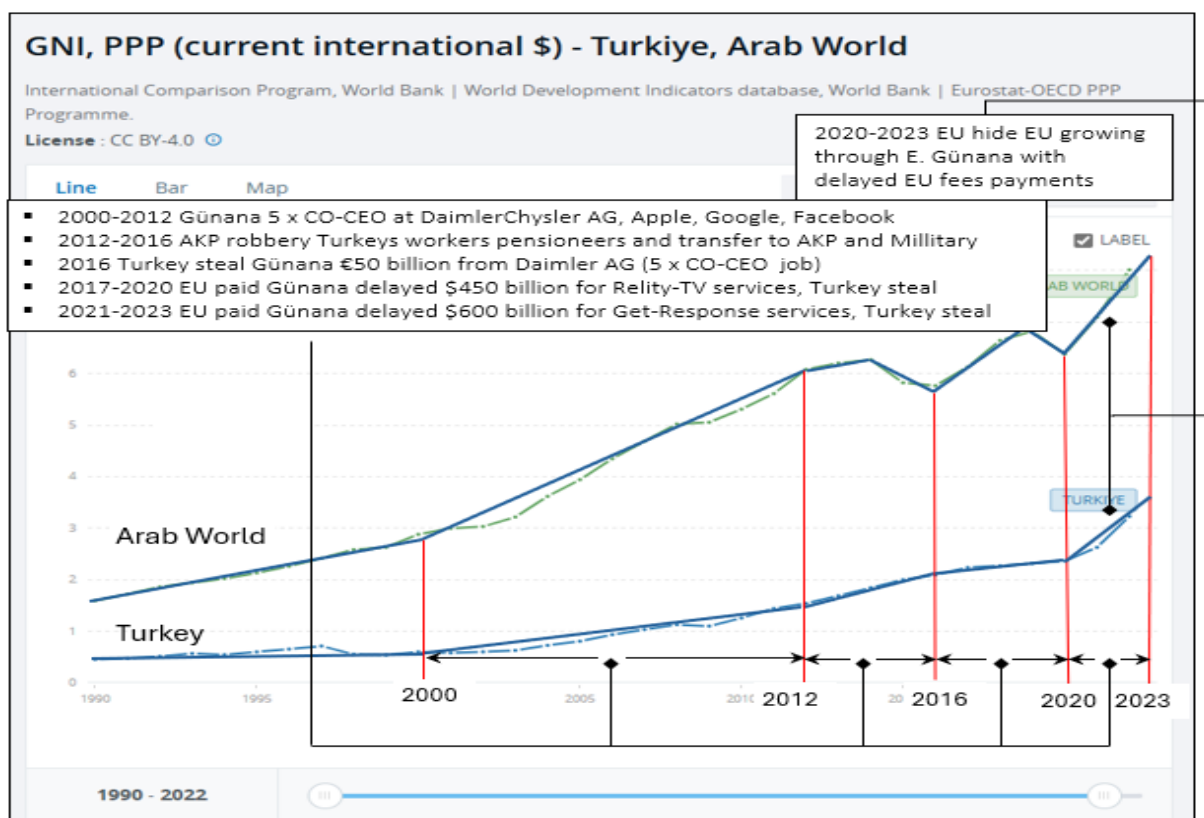
Chart 10: Turkey GNI per capita <https://data.worldbank.org/>

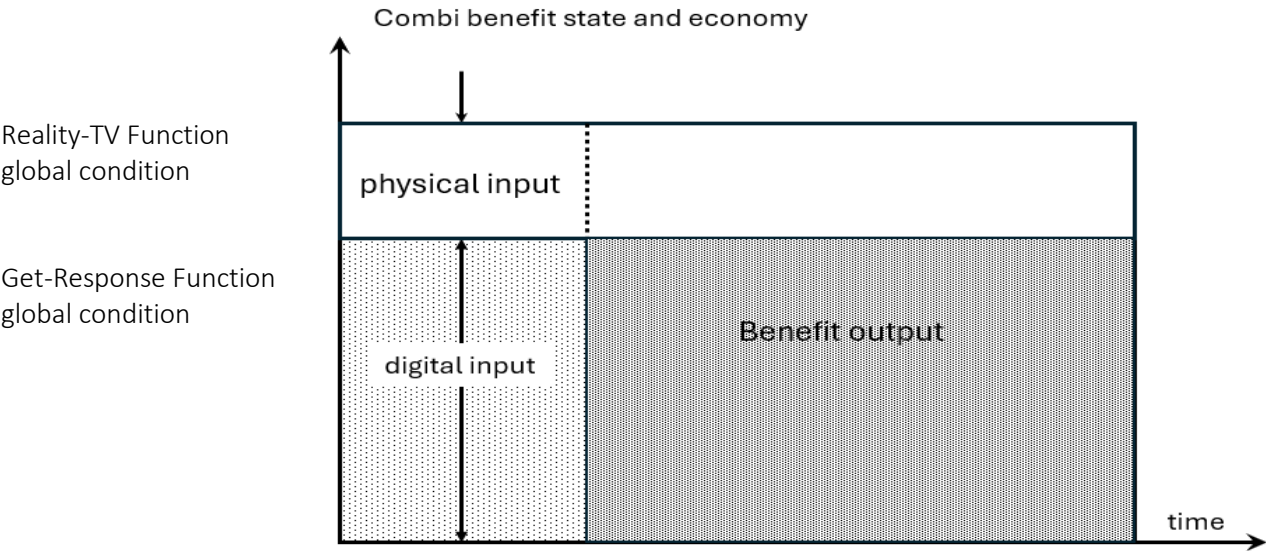


Chart 12: Reality-TV and Get-Response Functions input/output

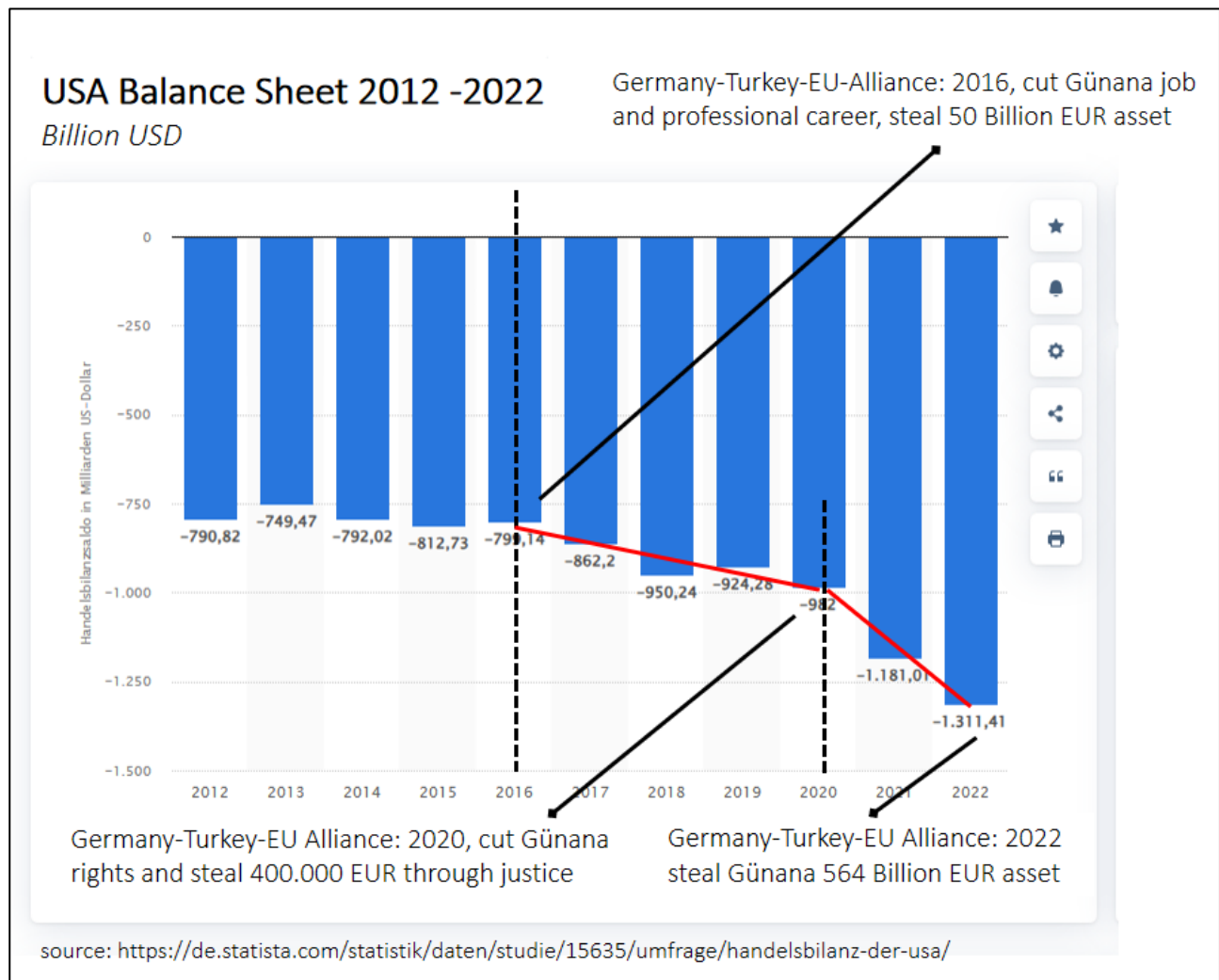


Chart: 14 USA Balance Sheet 2012-2022

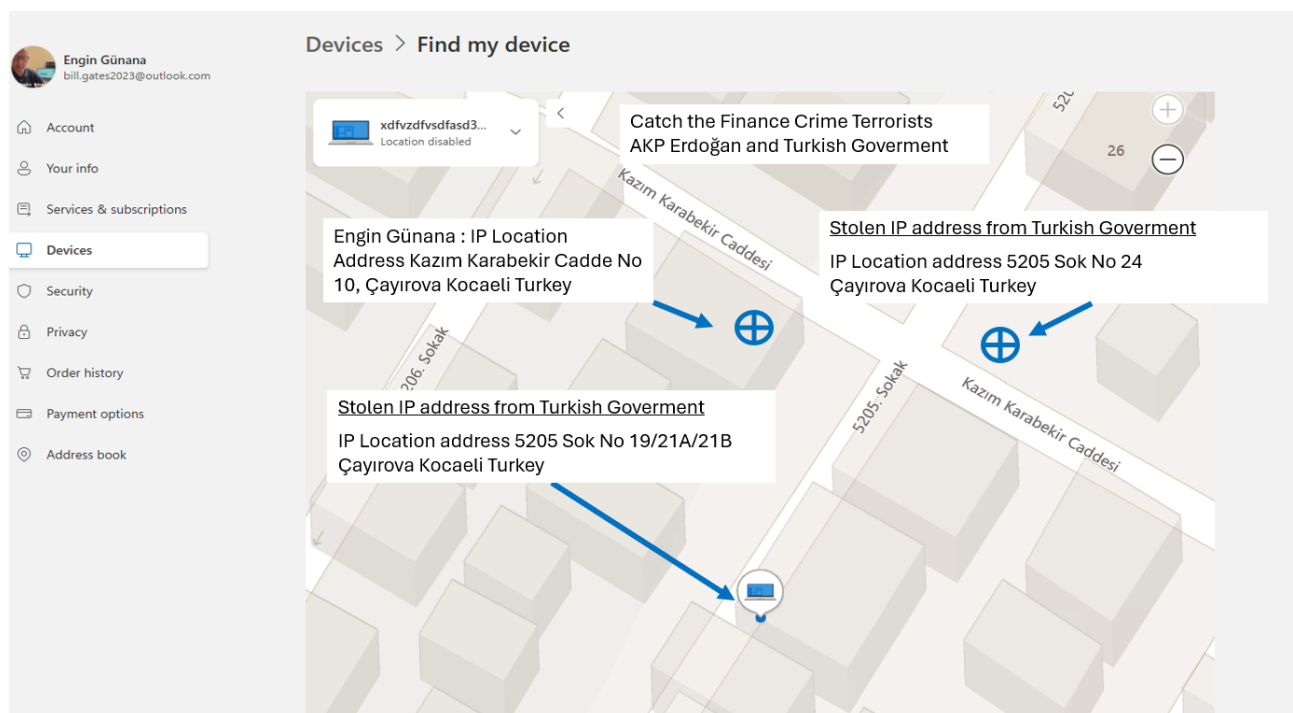
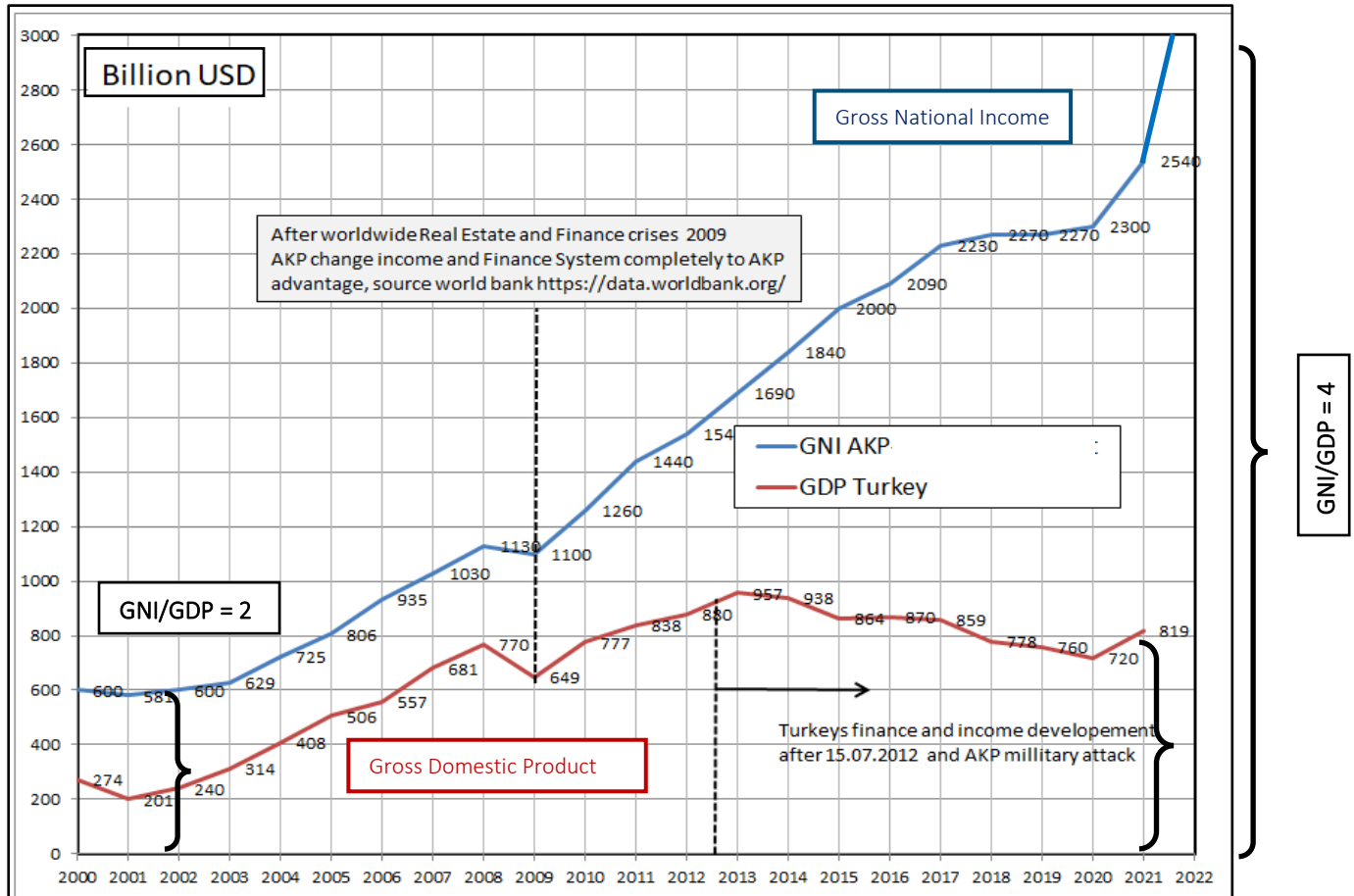


Chart 15: Stolen IP address from Turkish national guards

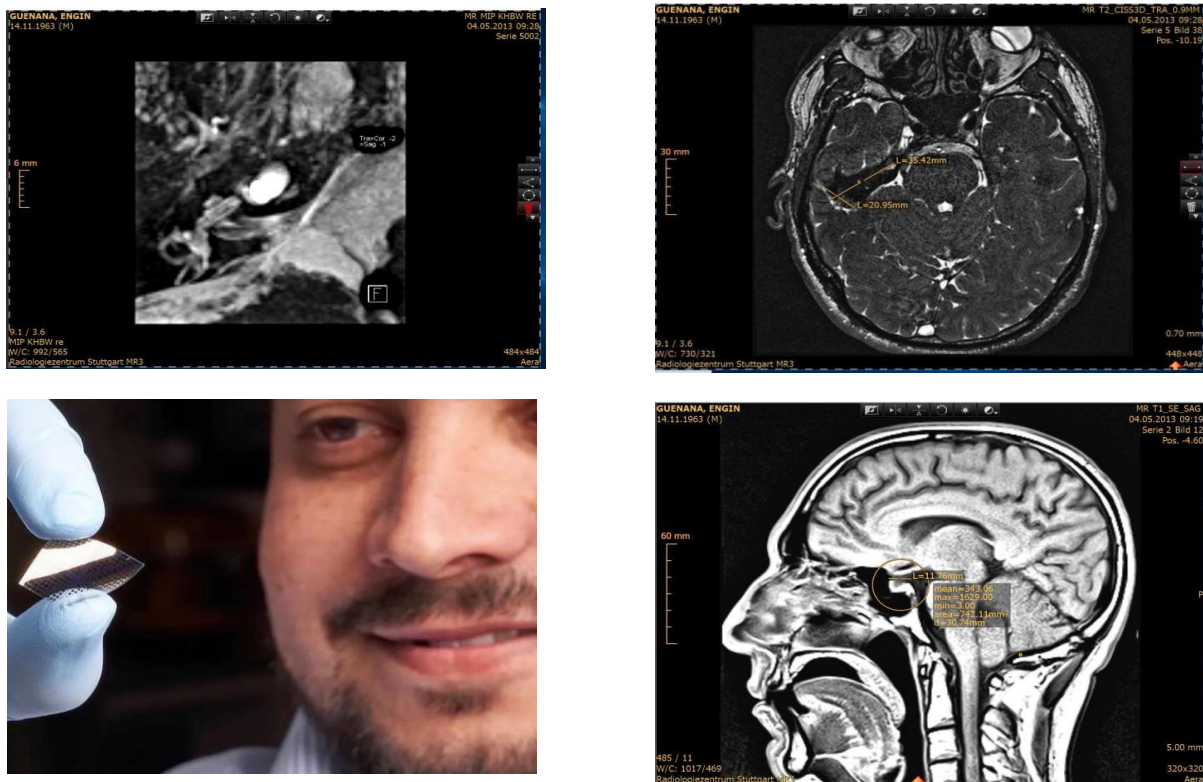

iPhone project was the reason of DaimlerChrysler merger, I show we my iPhone project and Steve Jobs, yes, we can, we can cooperate even though of the ocean, 10000 miles distance, Film Ocean 11 is as reminder to University Stuttgart Faculty 11 Aerospace (actual Faculty 6) our great IT foundation realize 21. century Video conference

A great job as Daimler AG chairman because of genius ideas and foundation, the key for chairman function at Daimler AG with very successful solution. From -30 billion USD lost during DaimlerChrysler 1998-2007 merger to 50 billion EUR earning with my technology and business program with the partner Renault and Nissan as cooperation partner during 2012-2016. Visitation of President Erdogan 1. Economic advisor Bülent Yiğit, former economic minister Mustafa Varank and former national intelligence chief actual secretary of foreign affairs Hakan Fidan. Ask me to work for Turkish government but with the danger to death. My answer of course not. I am a free and independent person. 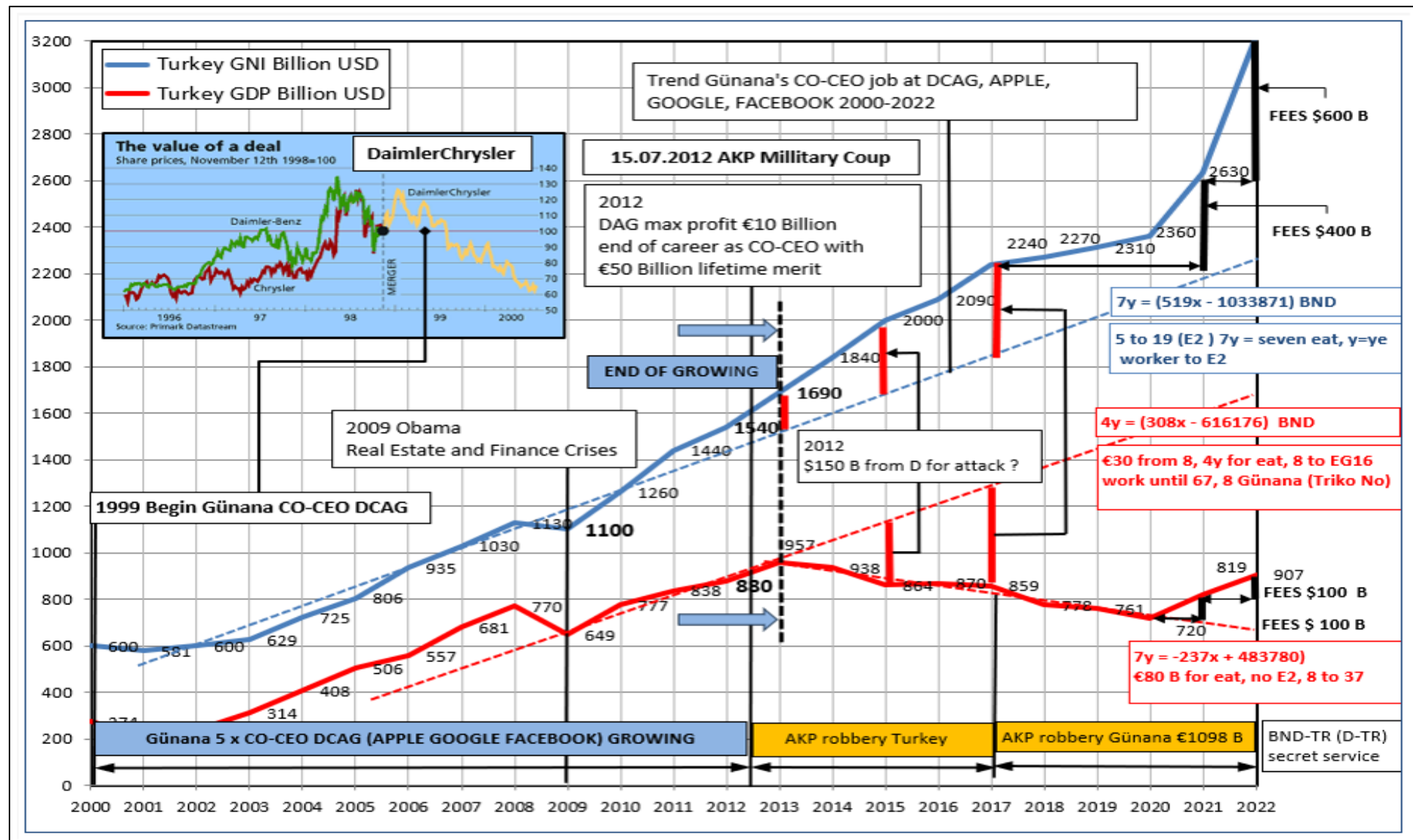

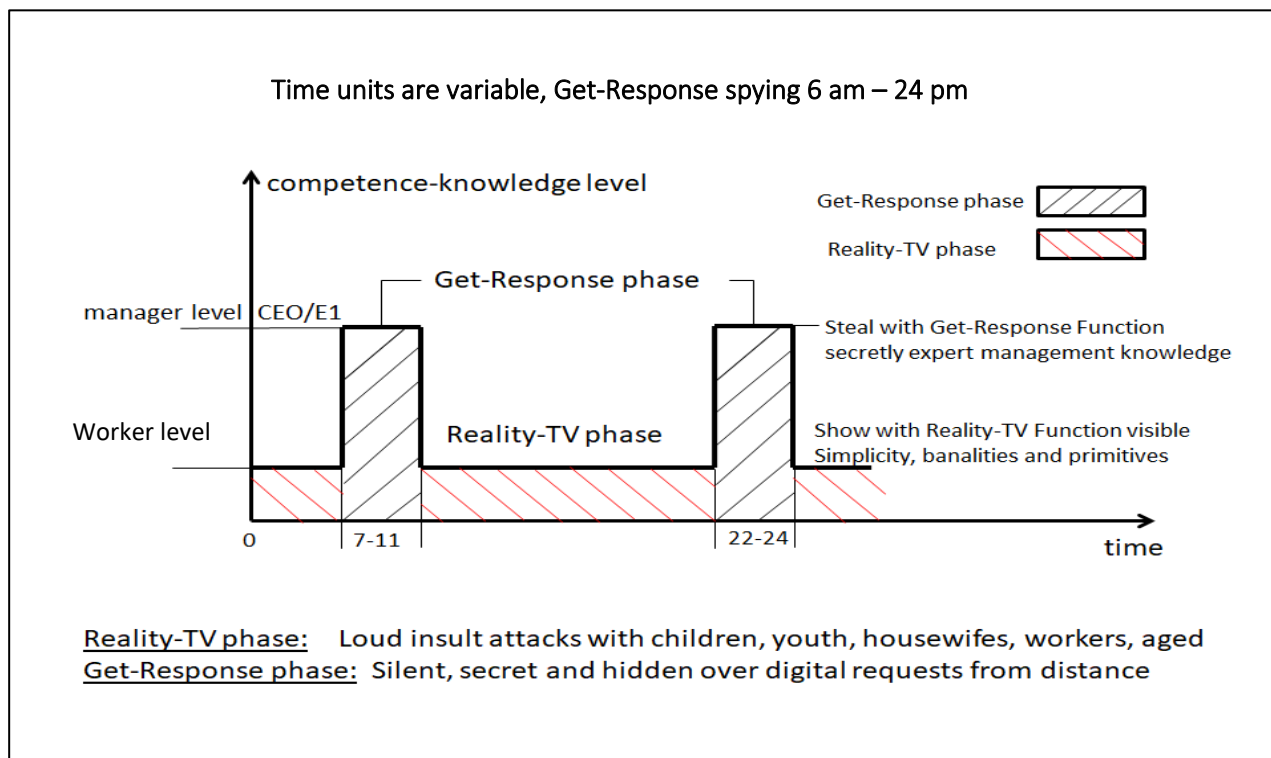


Chart 18: Symmetric/antisymmetric spying phases, absolute time and time units are variable

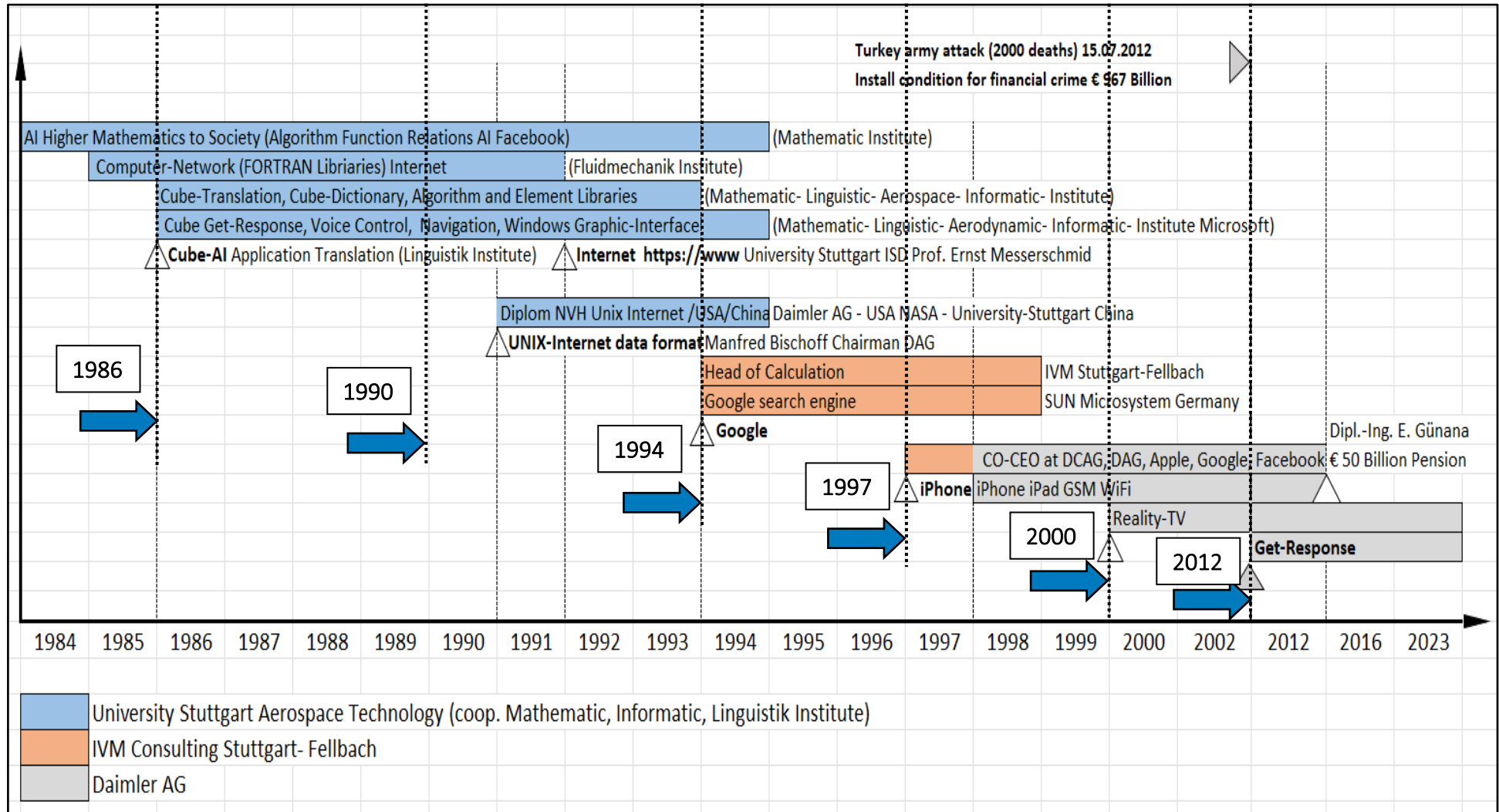

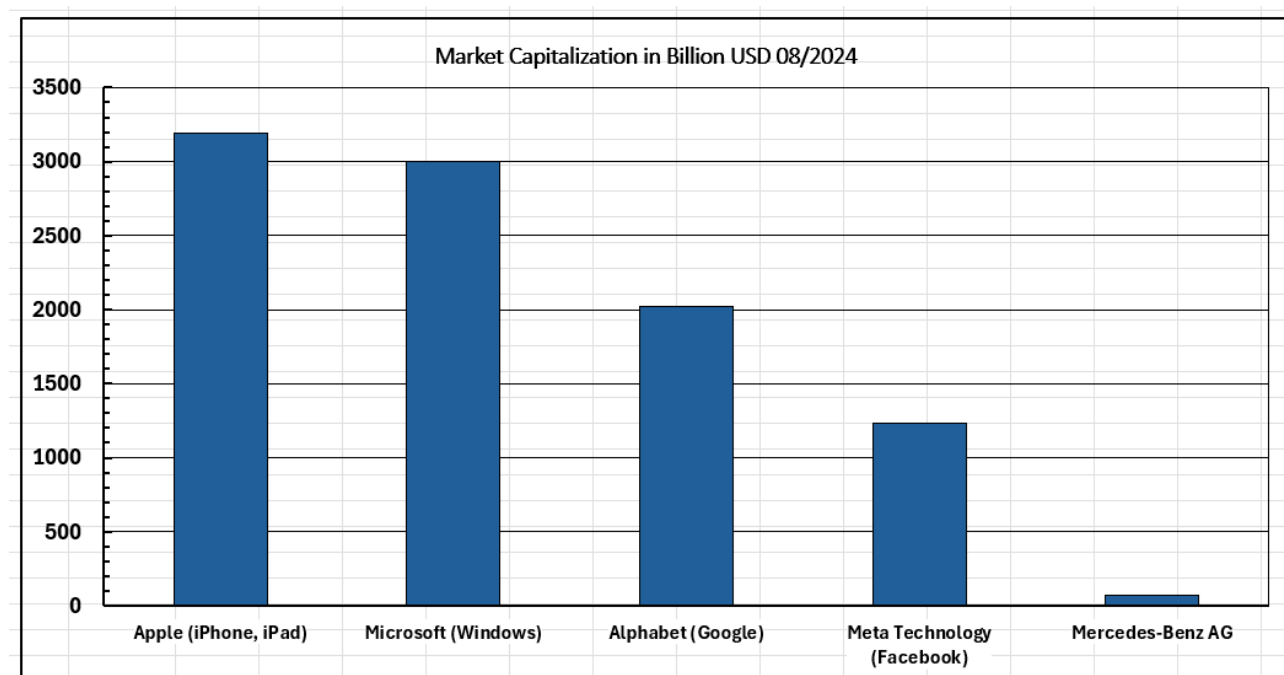


Chart 20 Benchmark market capitalization 2023

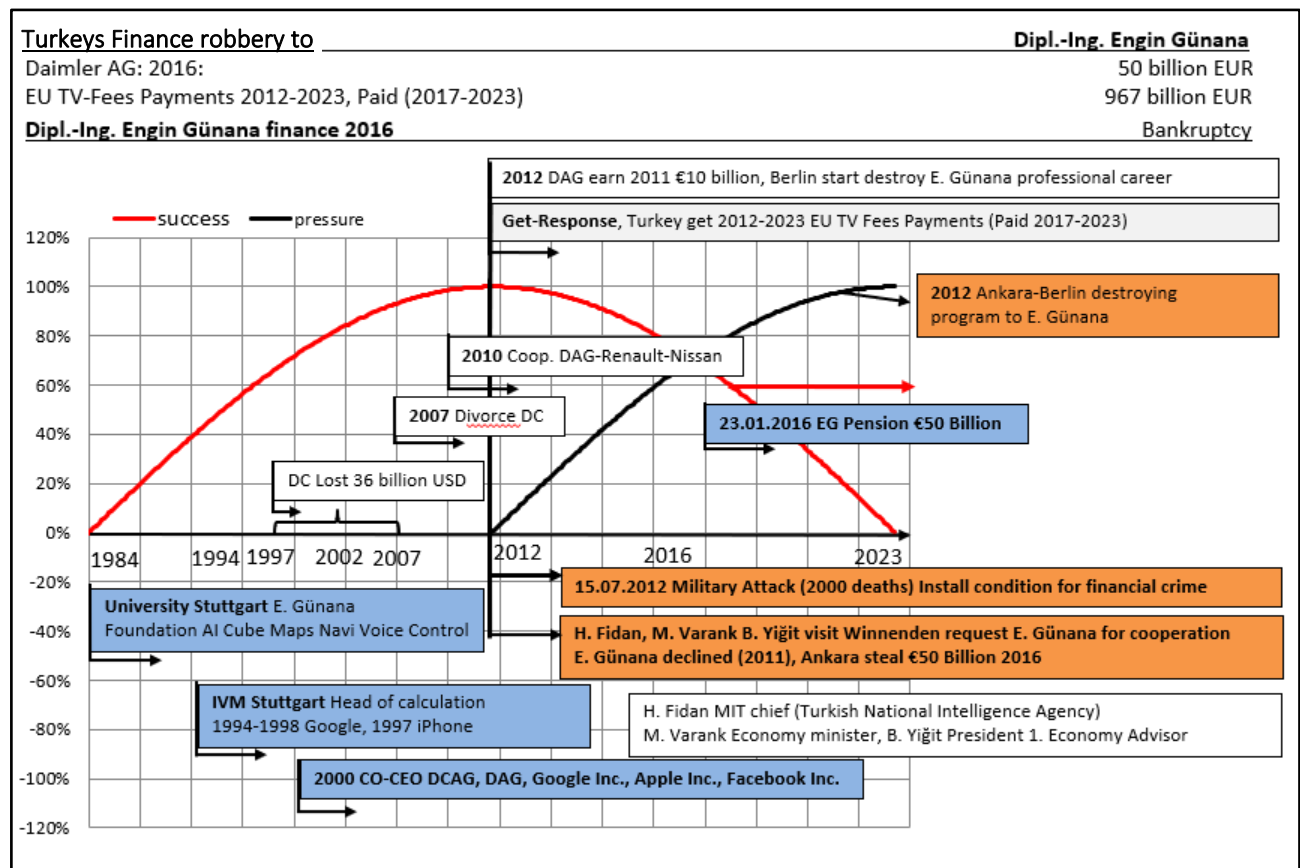

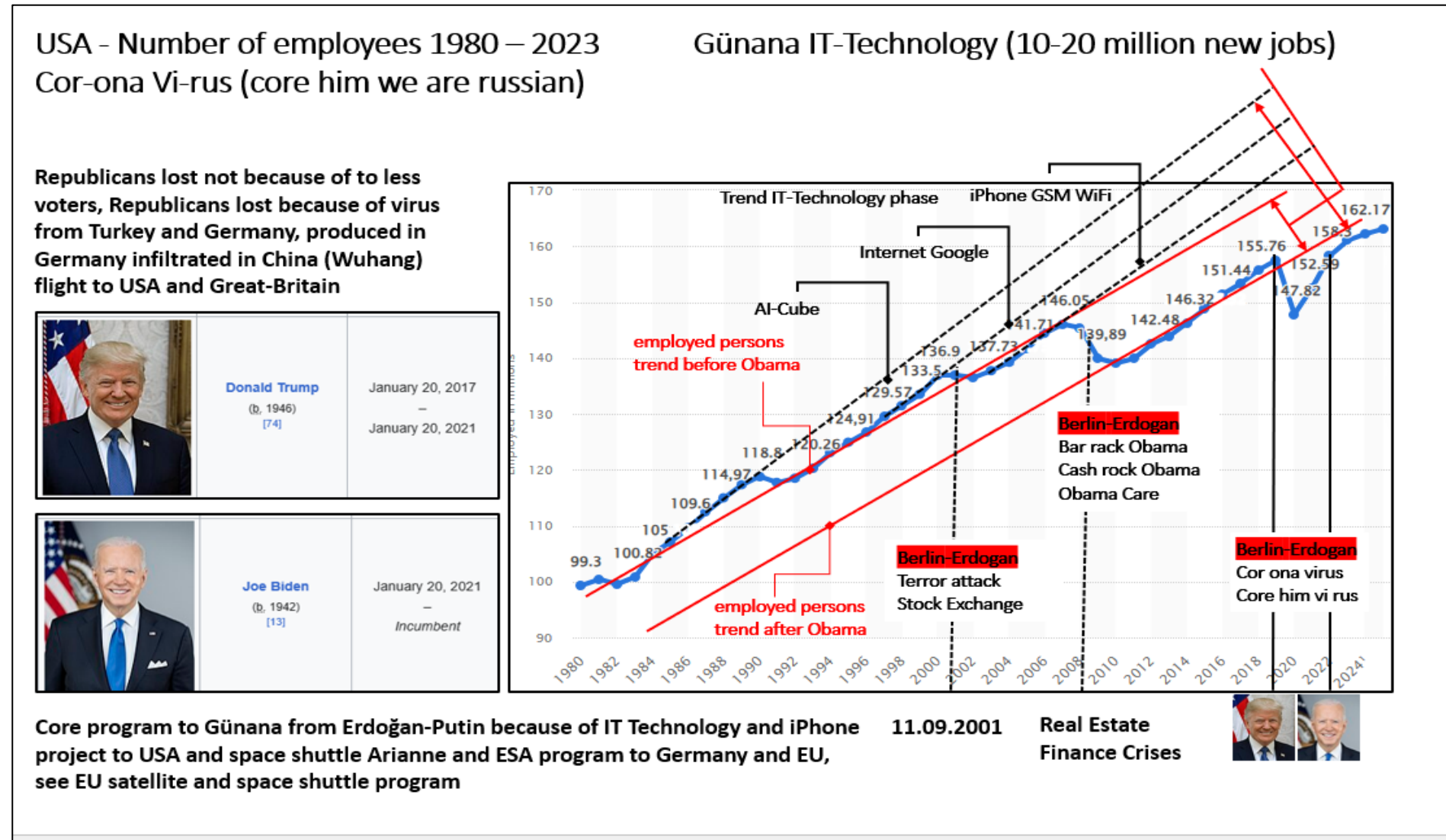


Chart 22 USA Employee 1984-2023

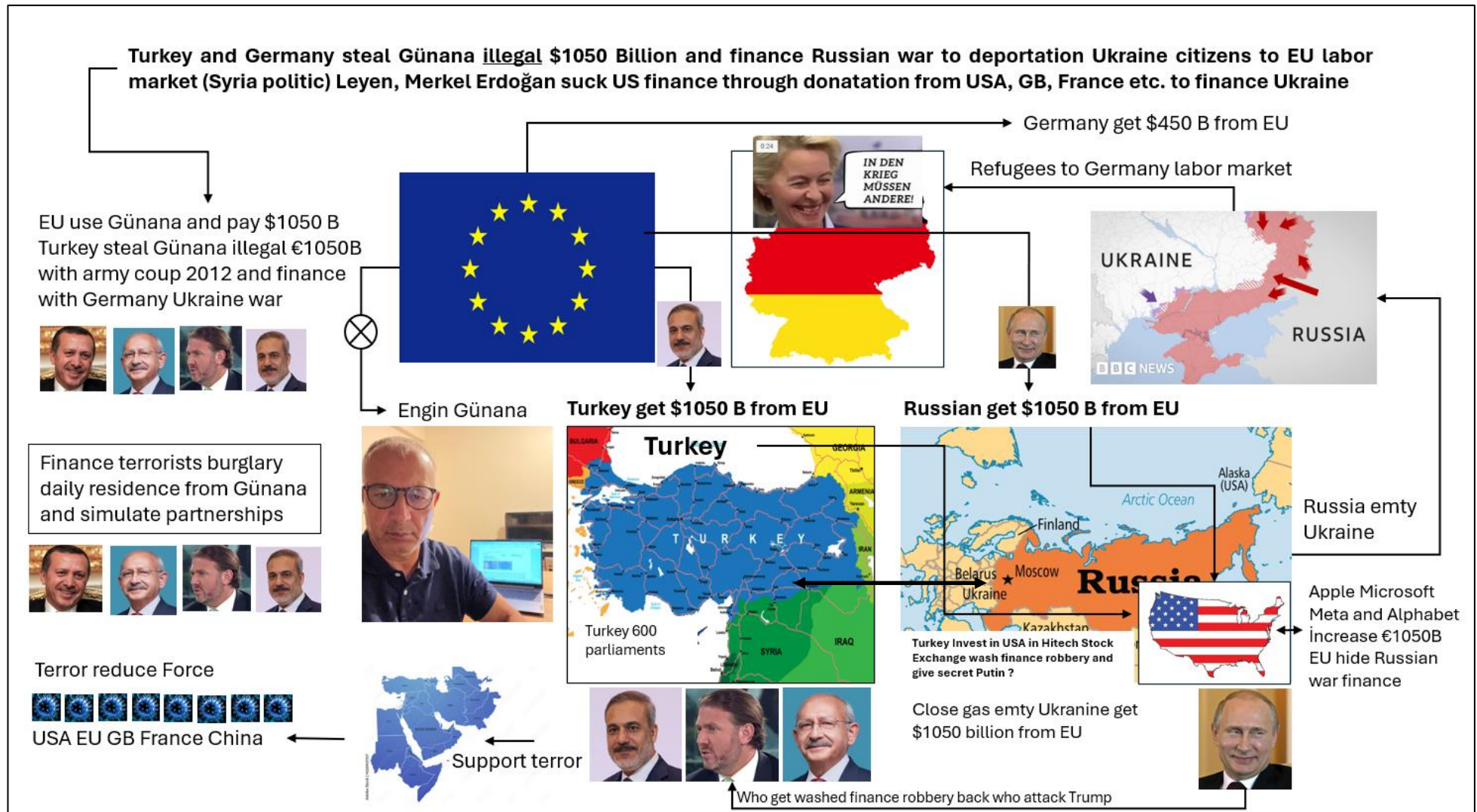


Chart 24 Reality-TV and Get-Response Fees Payments and Capital Flow

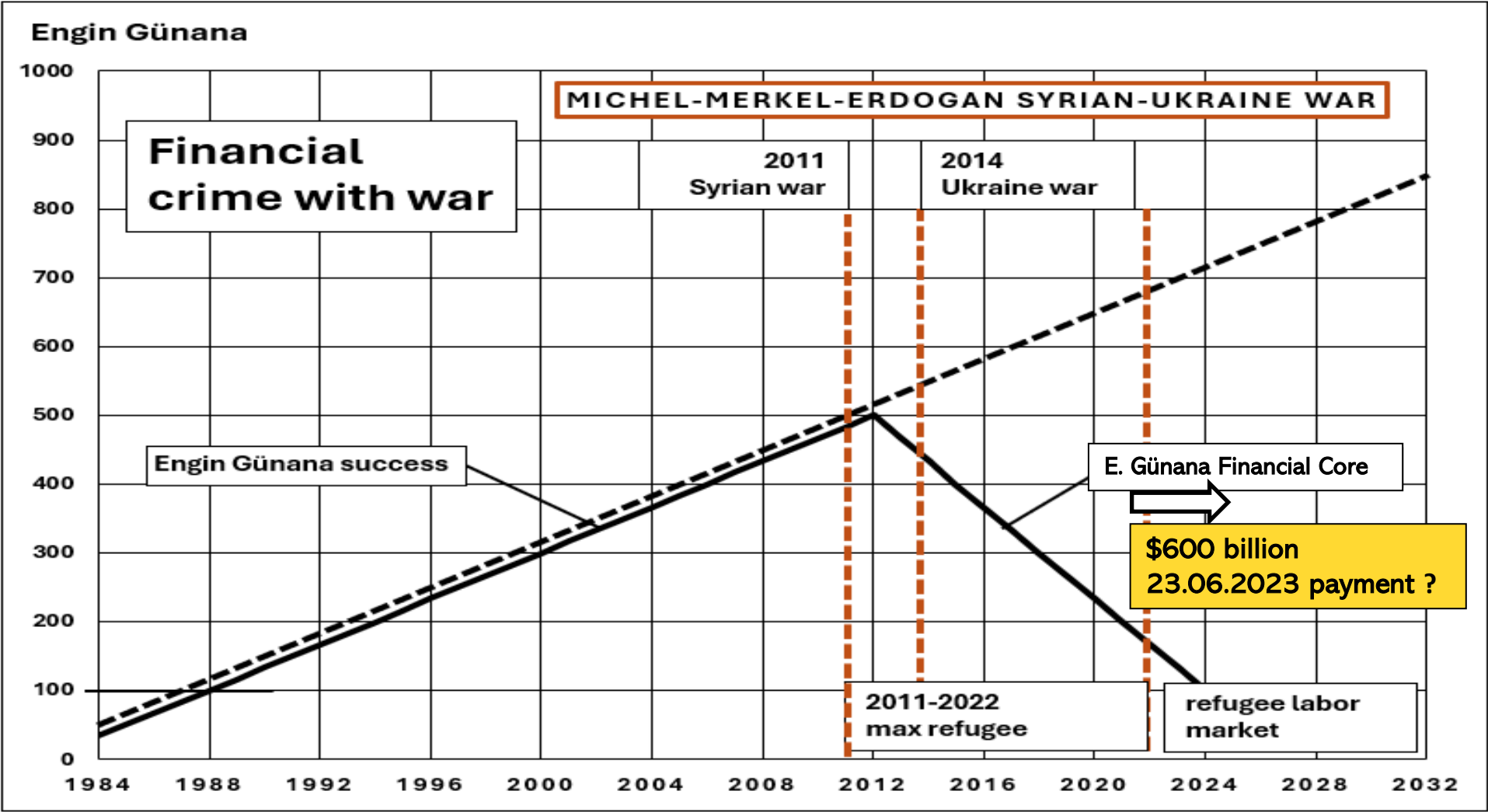

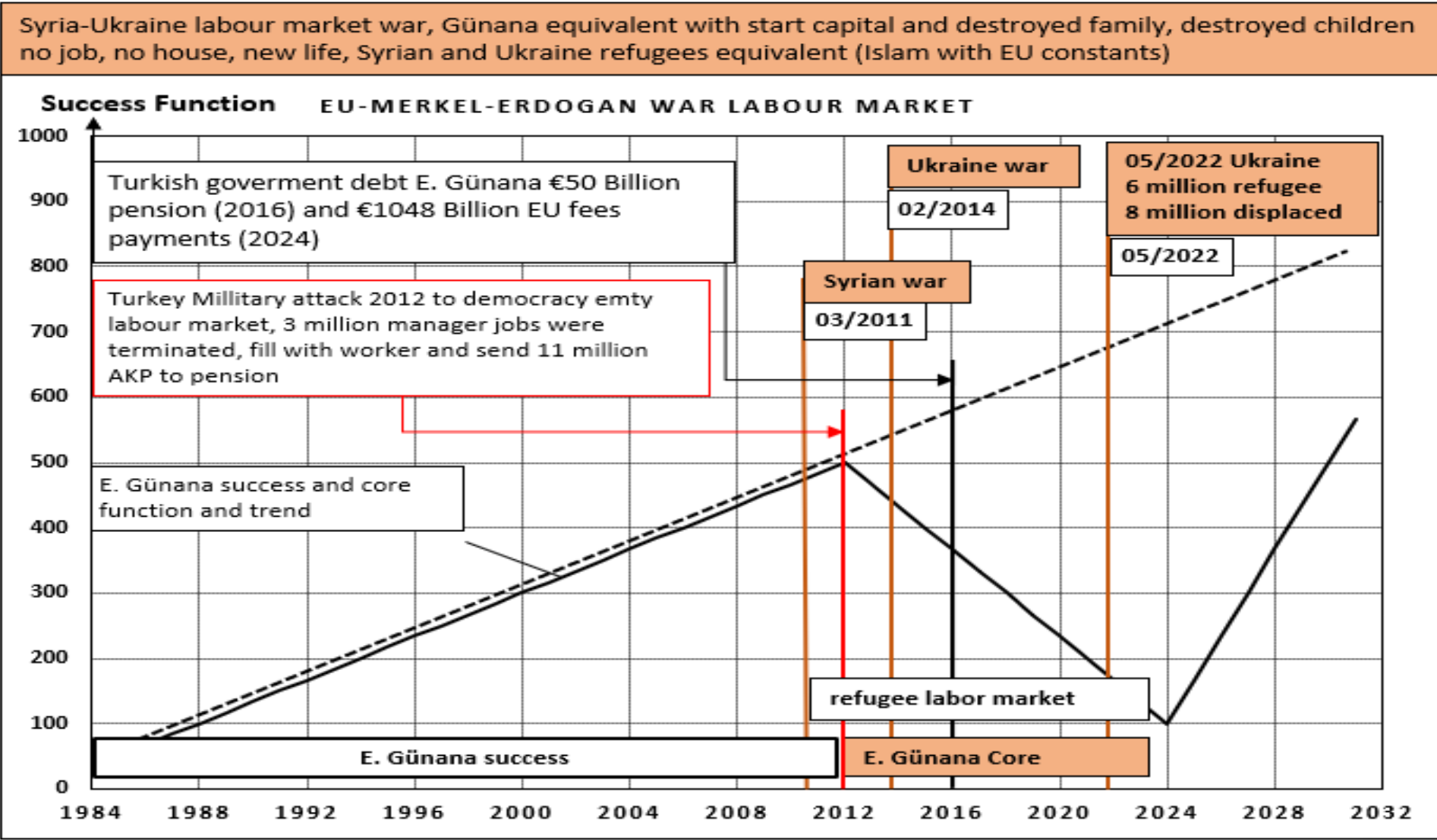

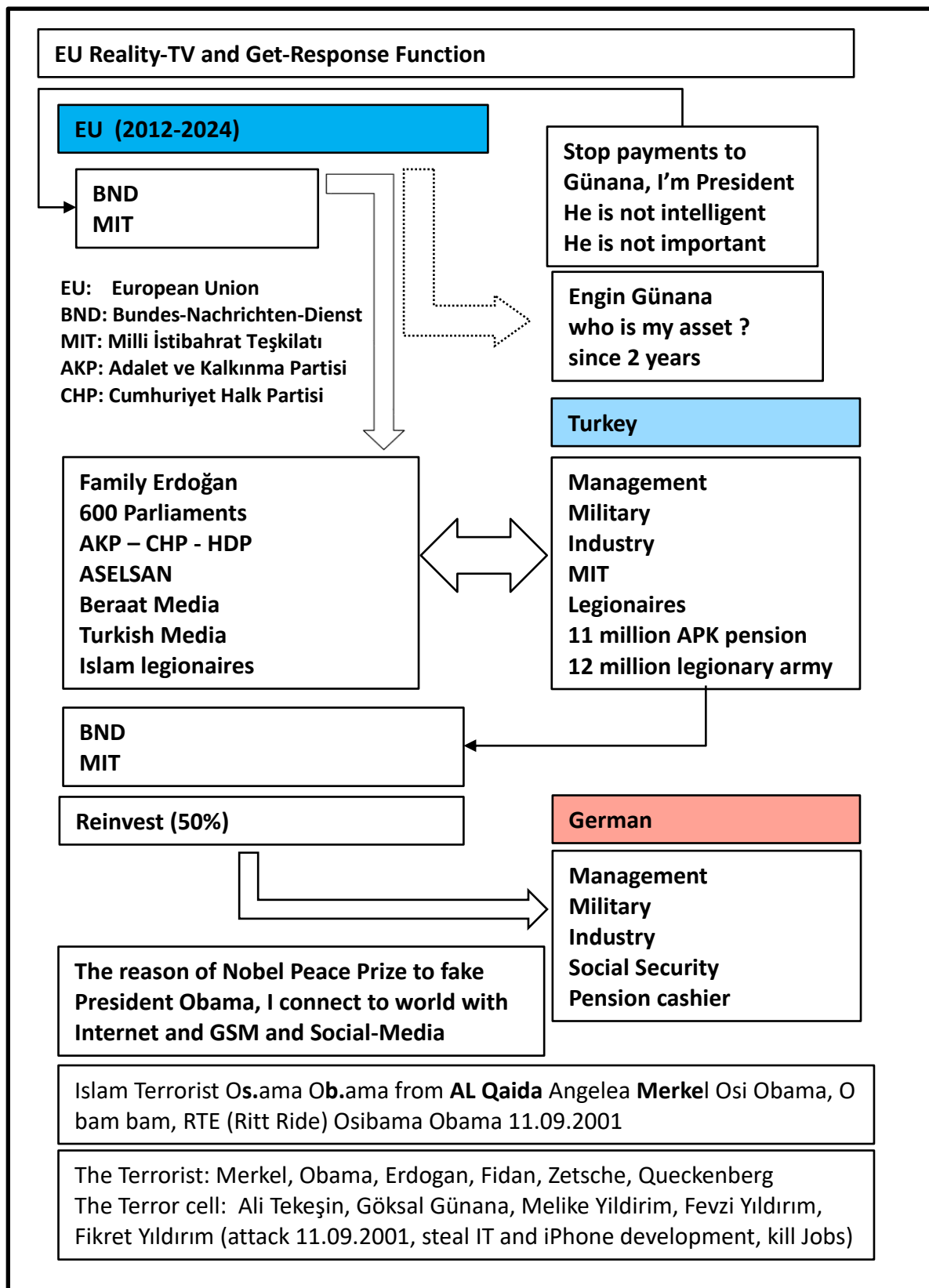


Chart 27 Capital flow chart between European Union Germany and Turkey

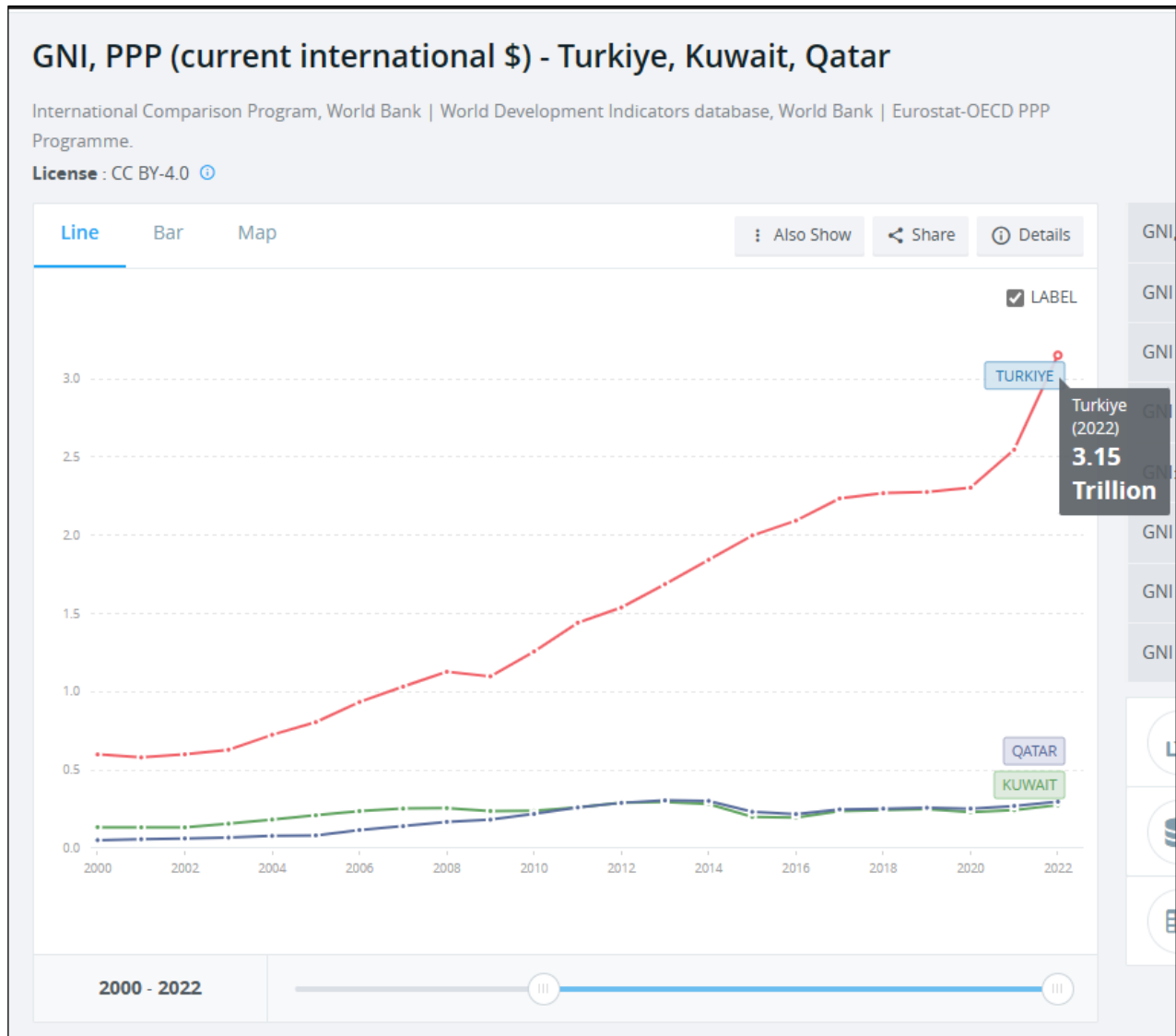


Chart 28 Turkey GNI 2023, 3150 USD

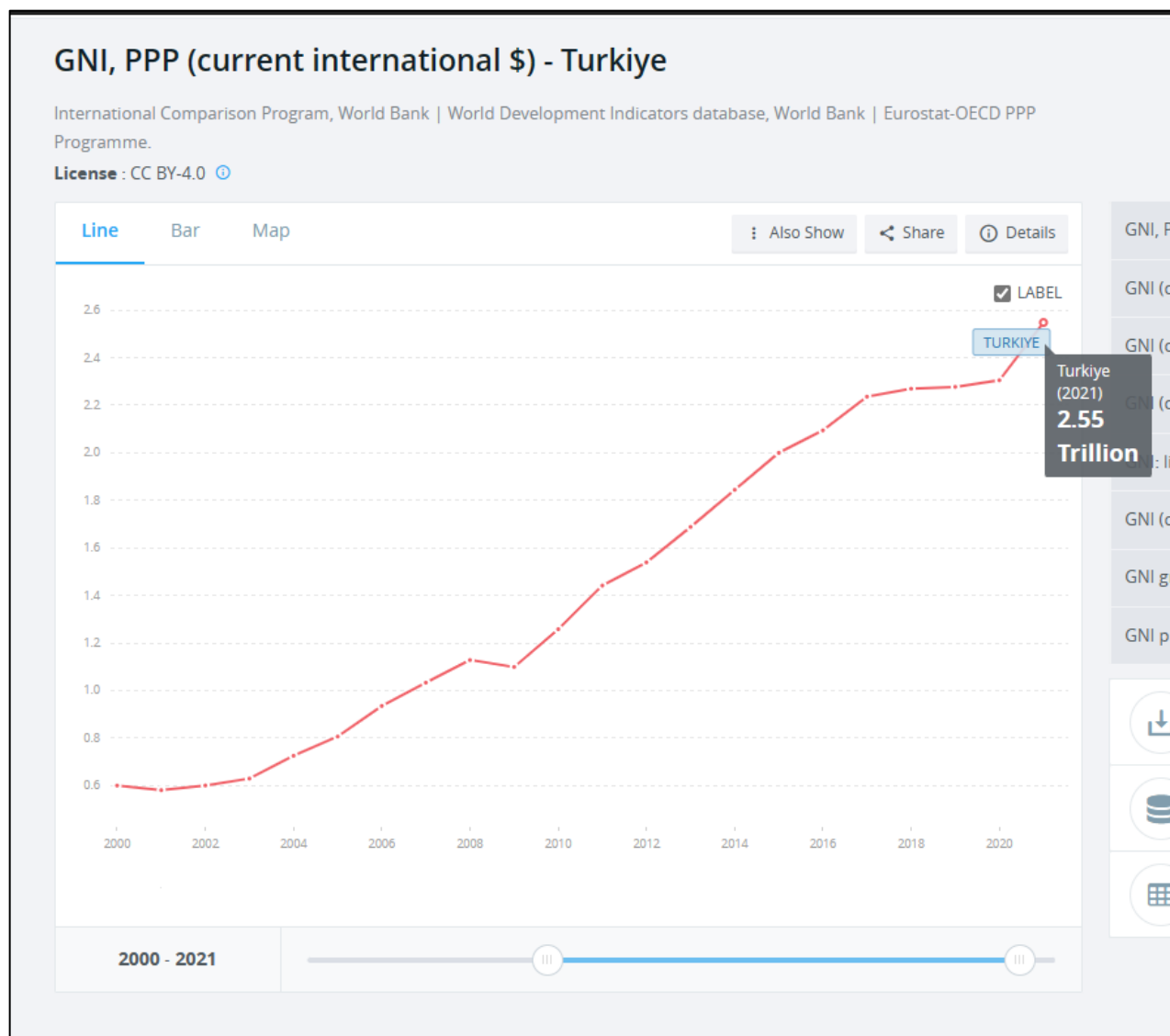

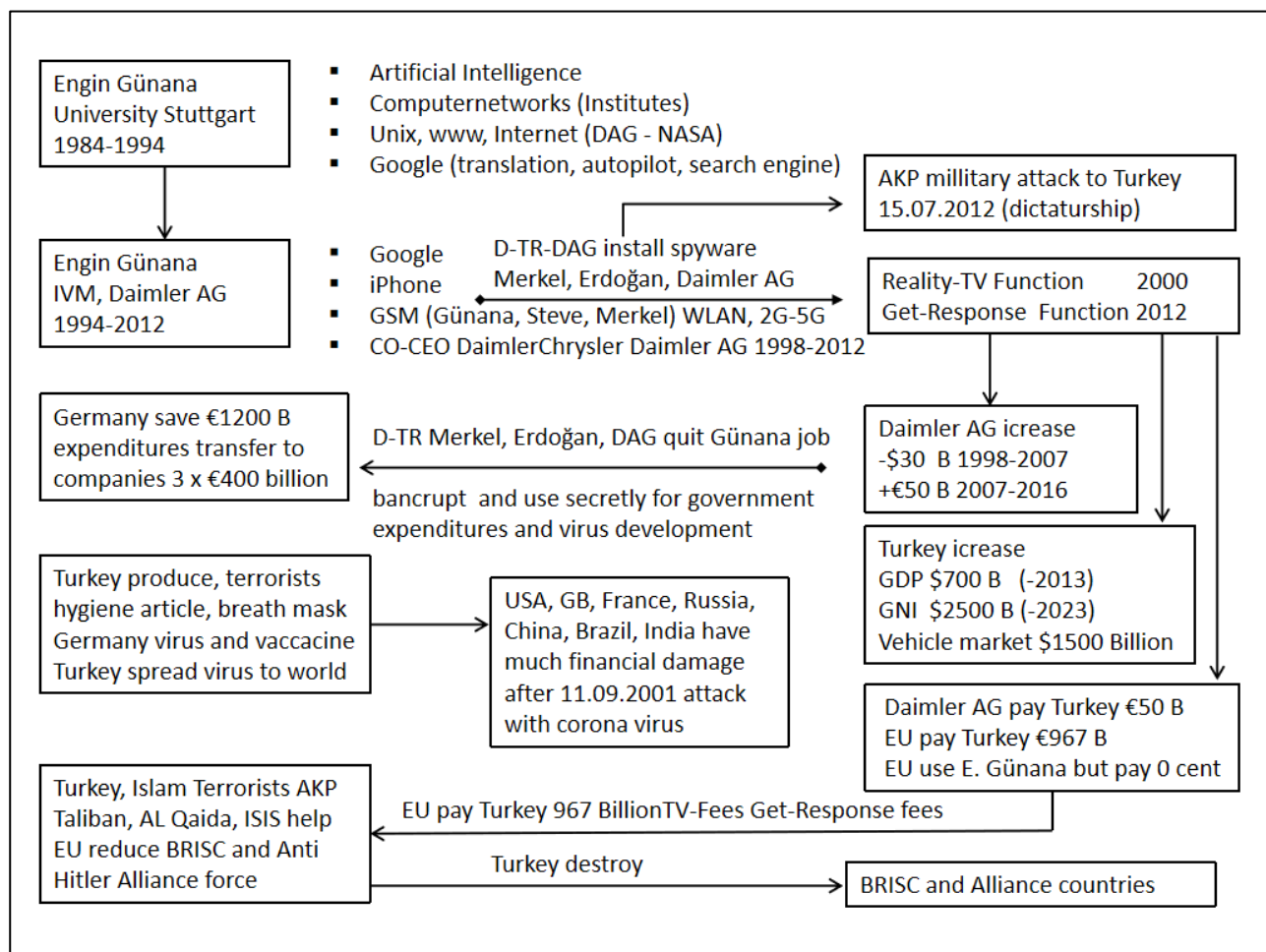

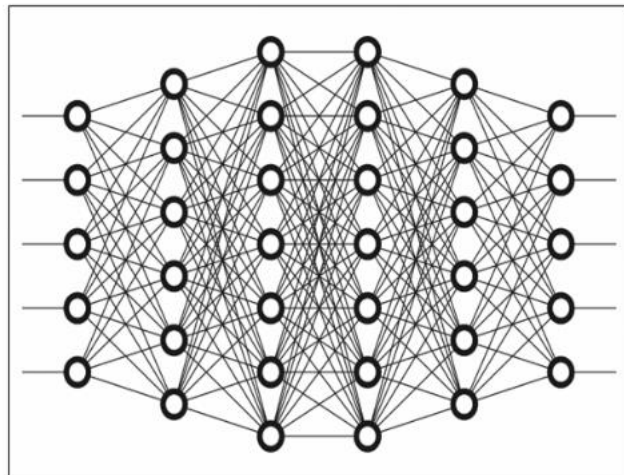
