

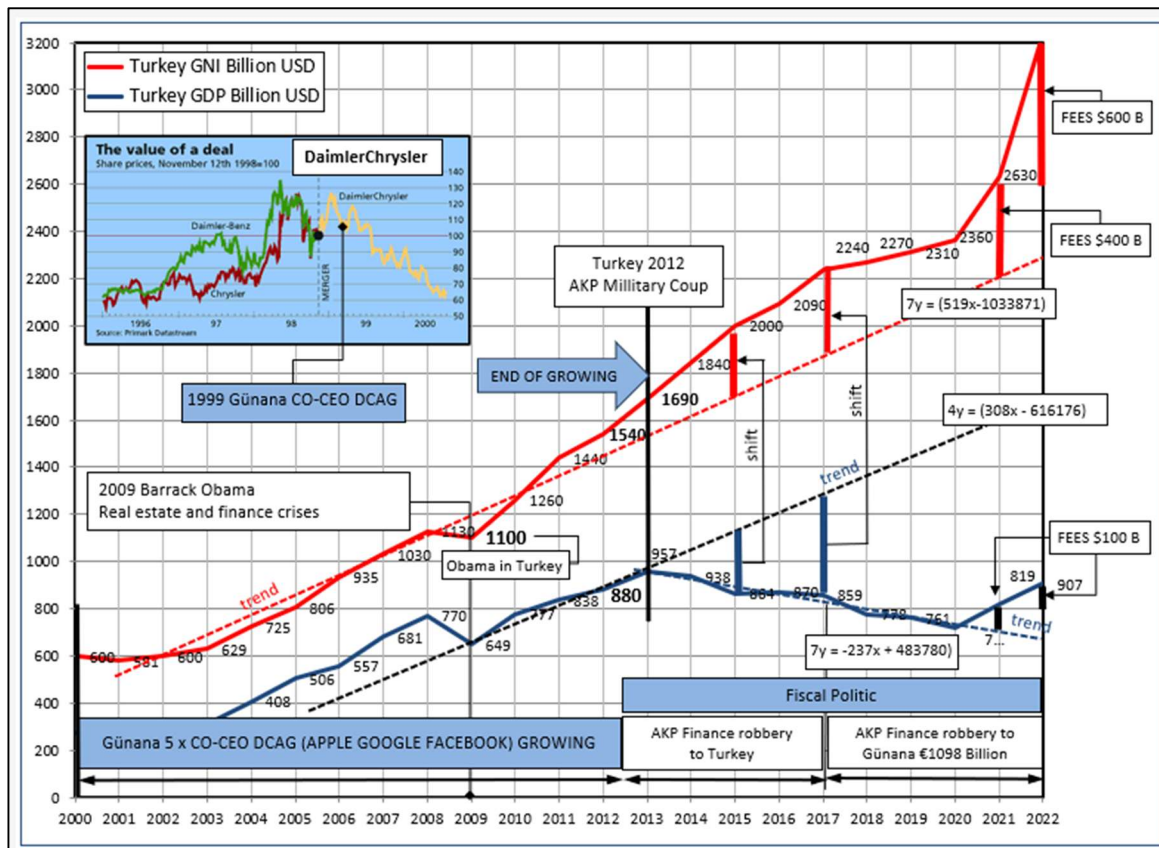


Chart 1: GNI - GDP 2000-2022

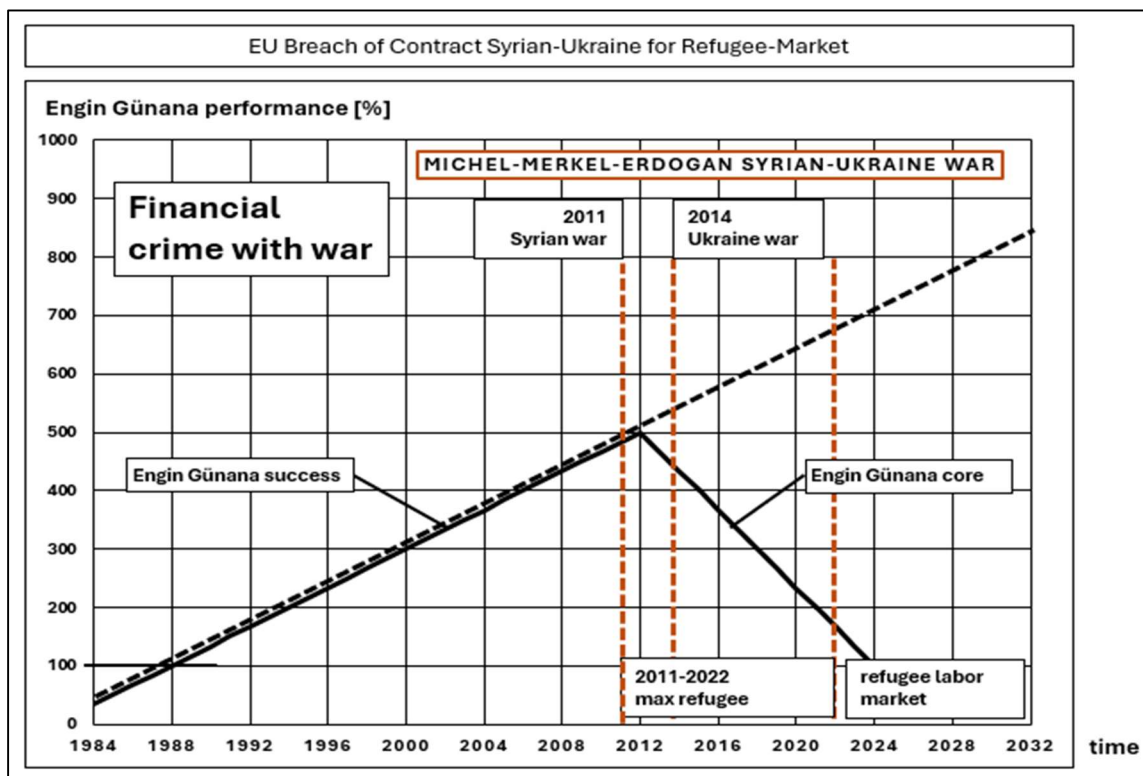


Chart 2: Syrian war 2011, Ukraine war 2014

Time Map IT-foundation - co-chairman at DCAG - Reality-TV Get-Response Management Function

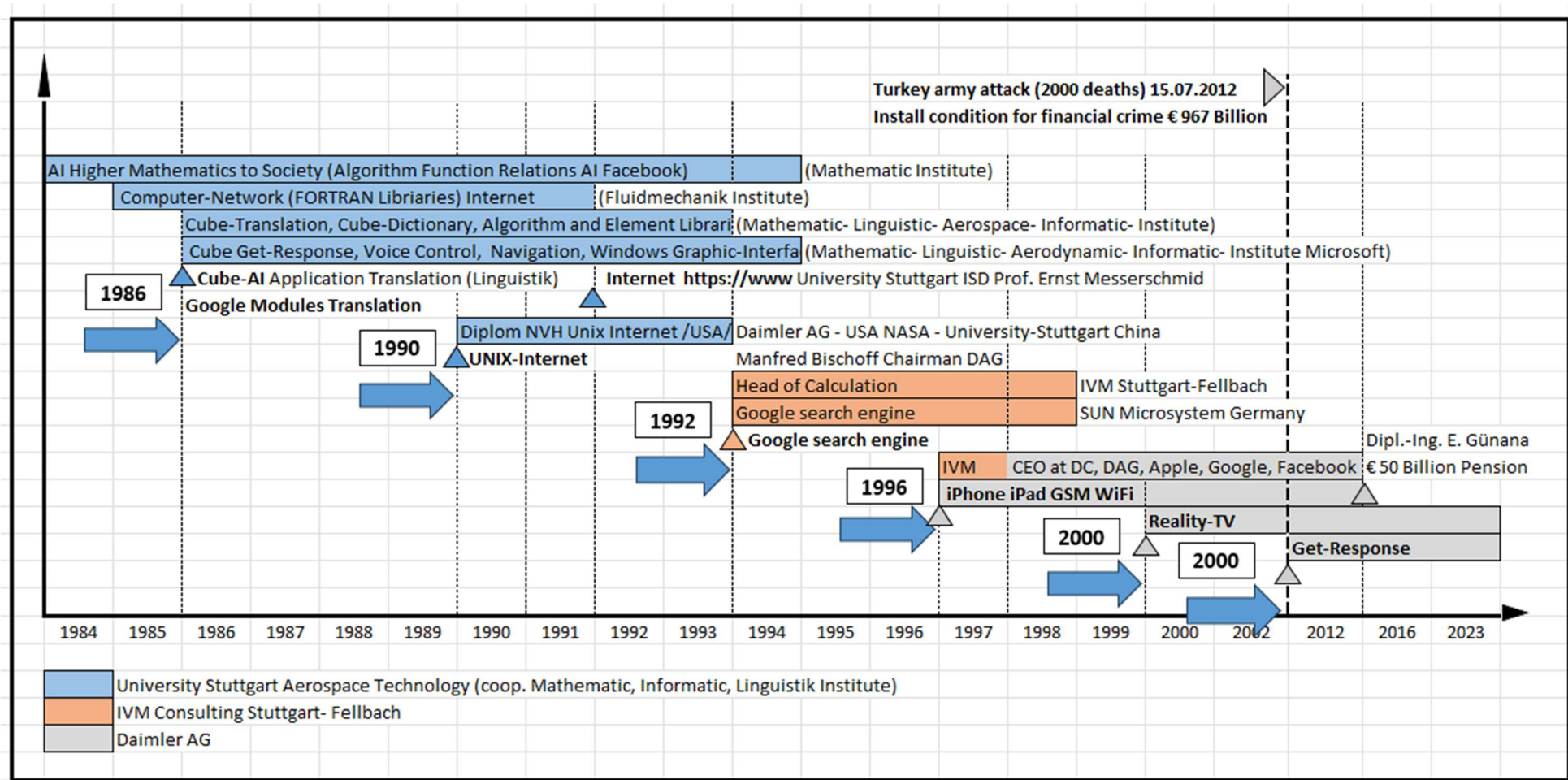


Chart 3: Timeline IT-Foundations, co-chairman job

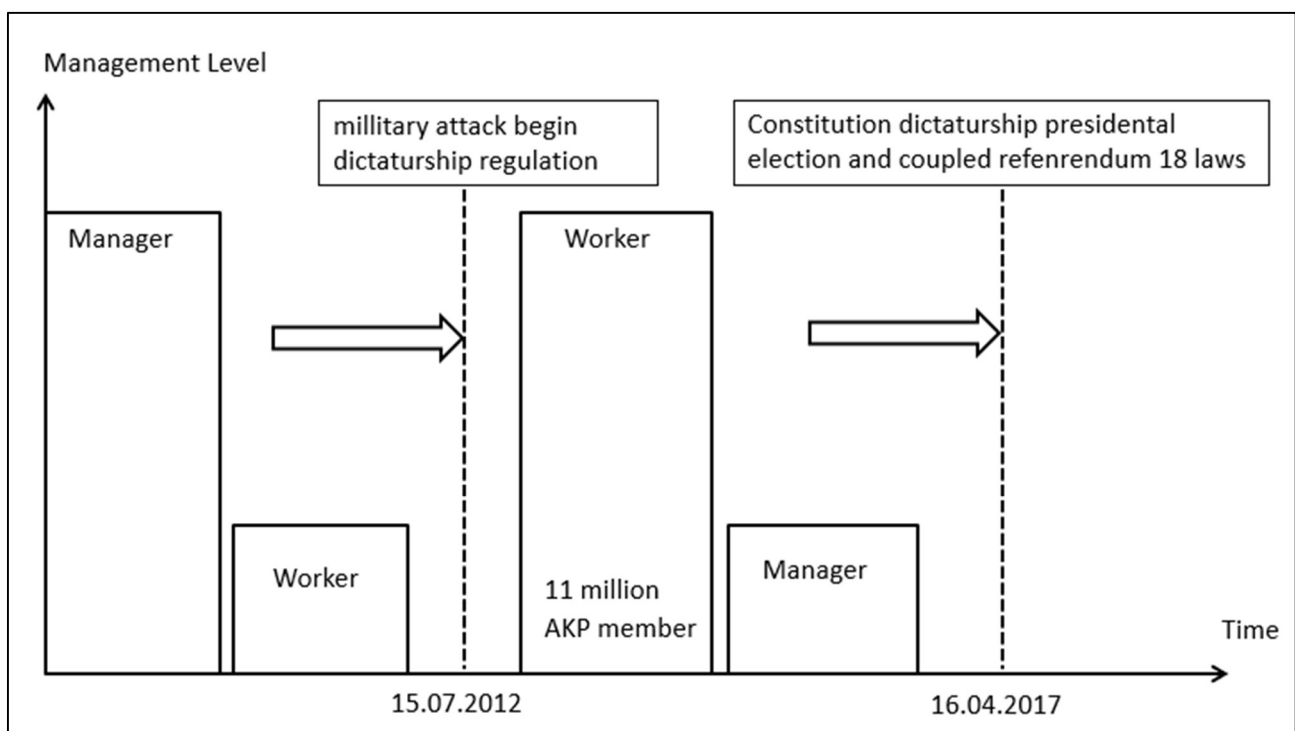

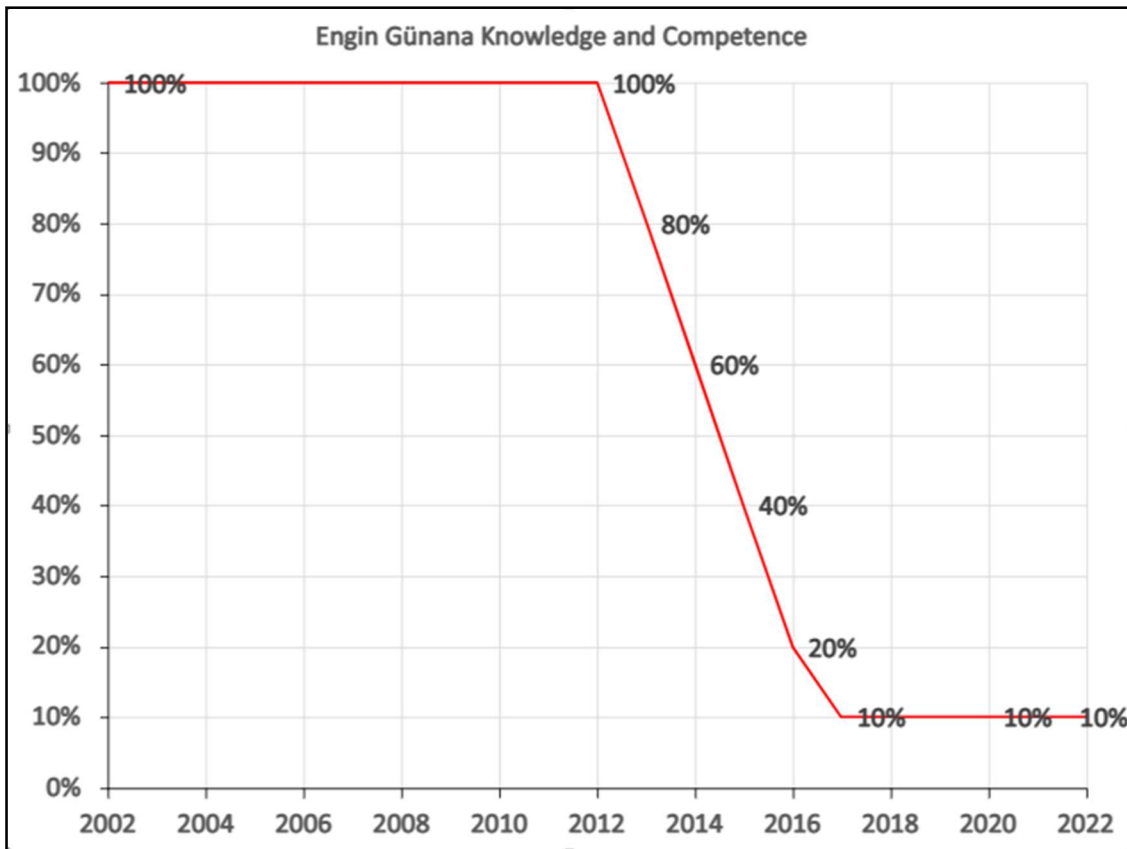

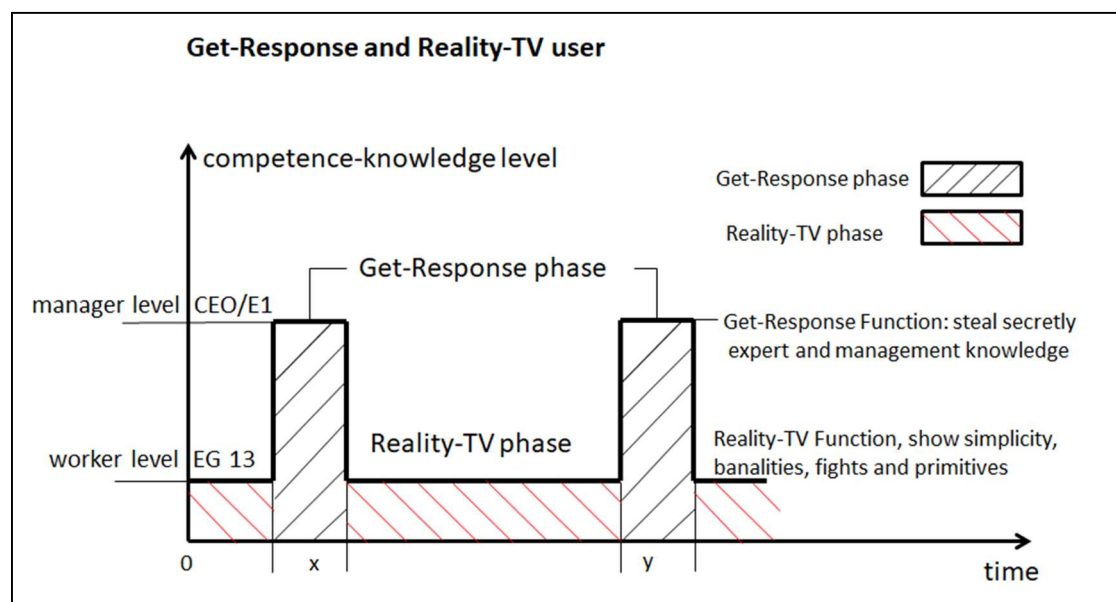

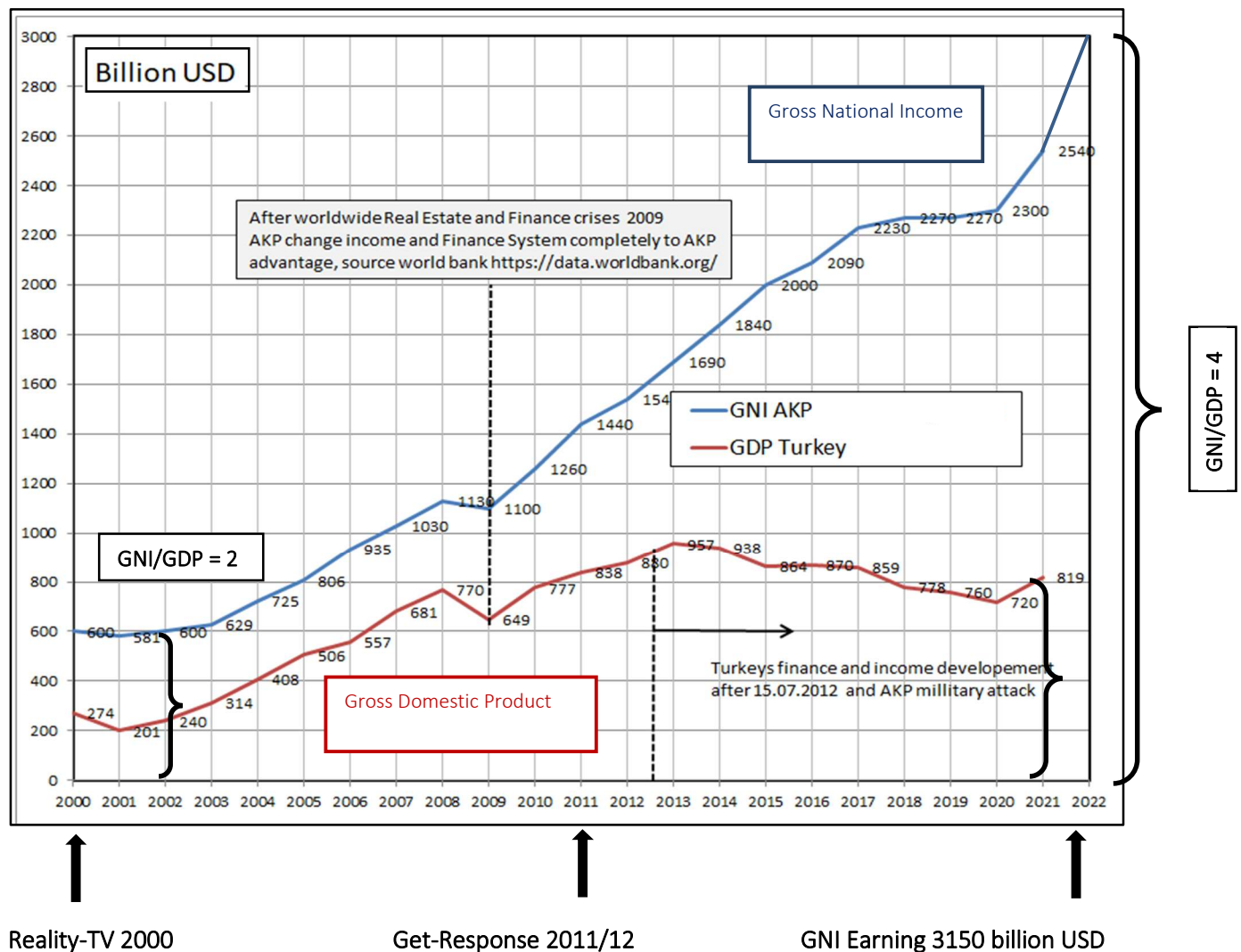
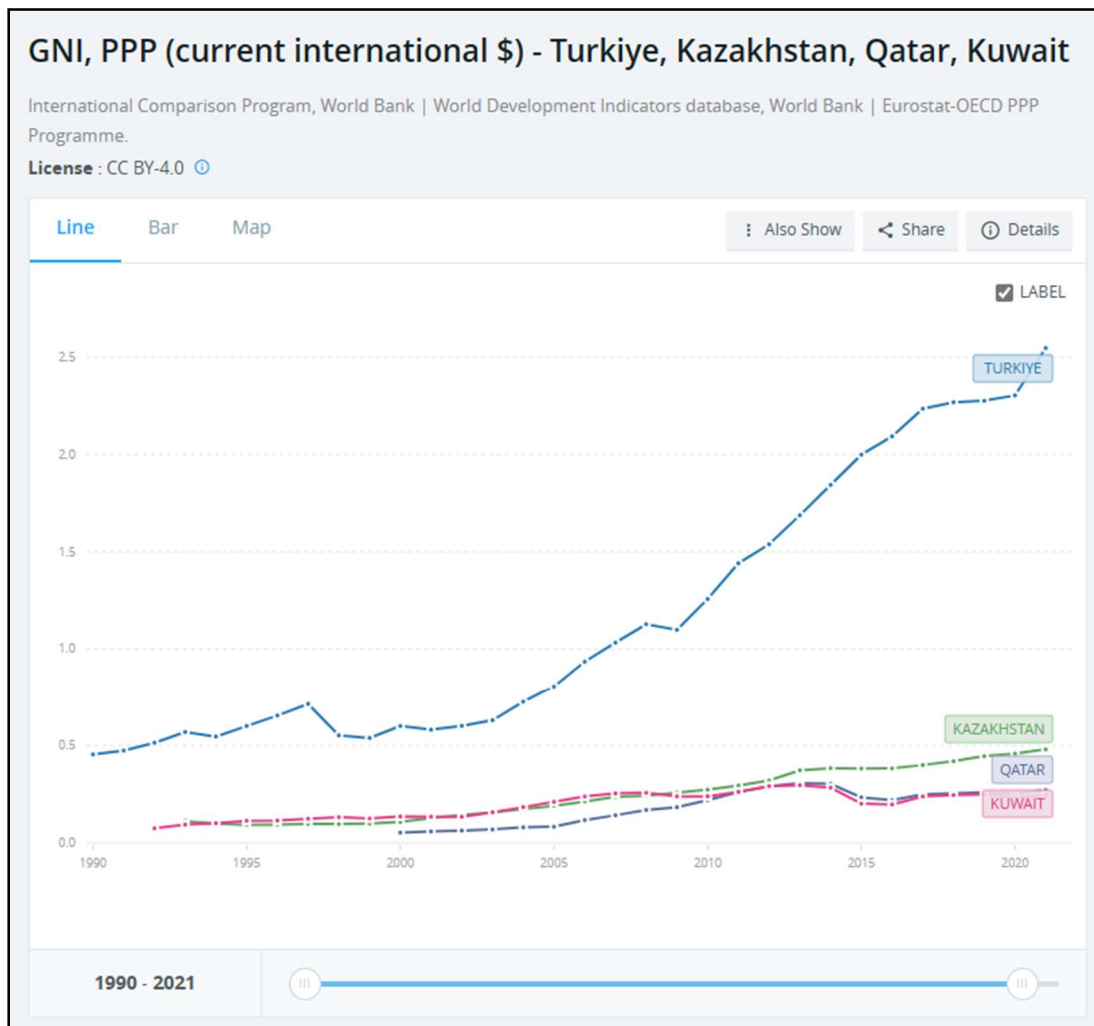


Chart 7: GDP-GNI drift Turkey's income 2000-2023 through AKP bankruptcy politic to society and opposition

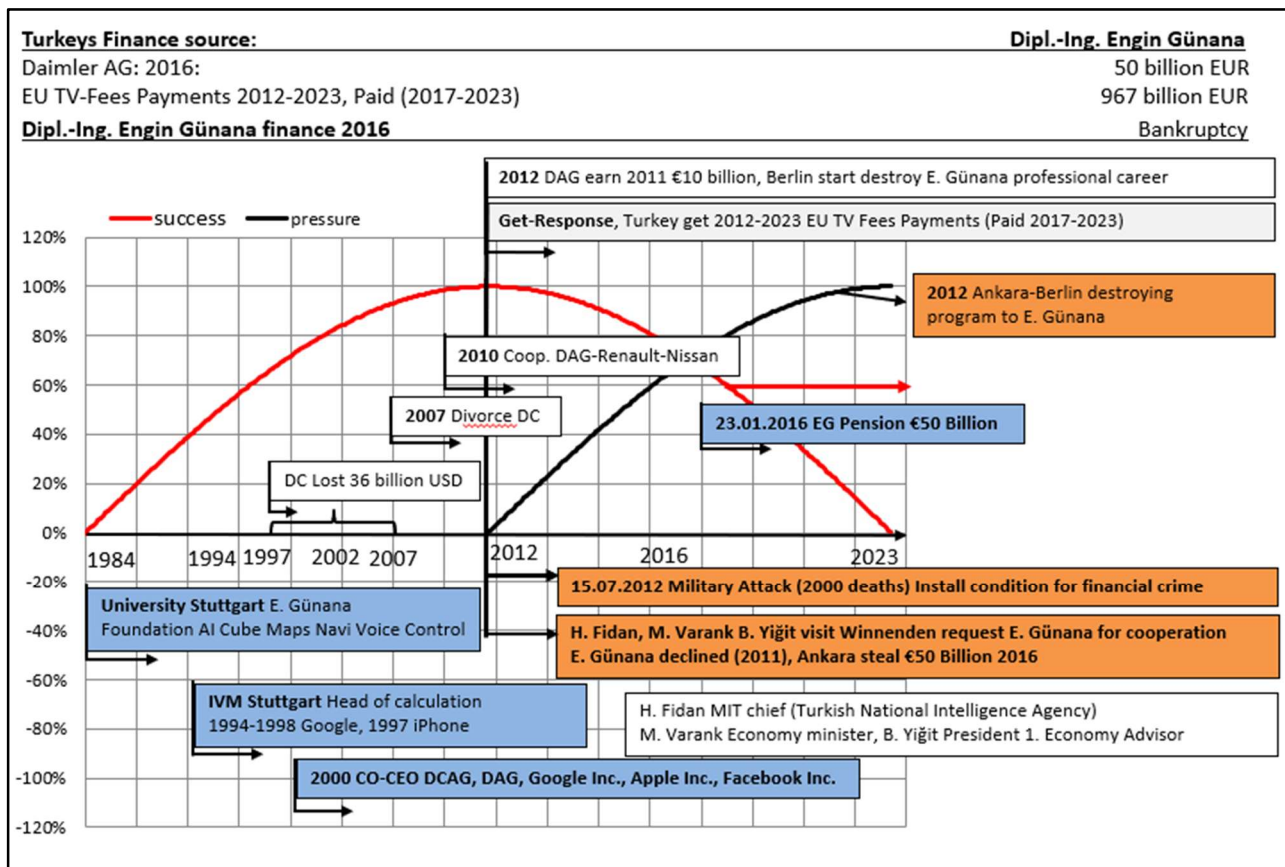

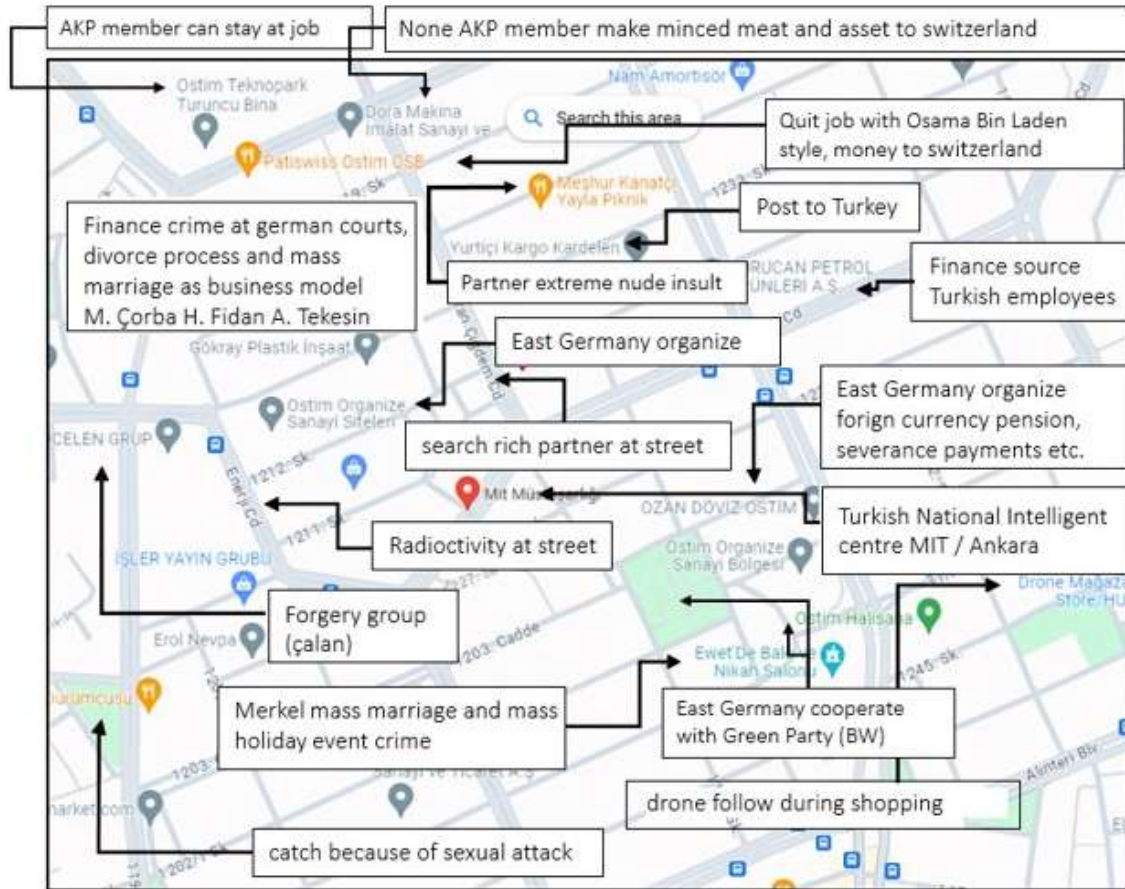


